## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by adding Section
5-38 as follows:

14 <u>the most recently completed fiscal year.</u>

15 <u>"Investment instrument" means an individual investment</u>
16 <u>security as provided for under the Uniform Commercial Code or</u>
17 <u>the aggregate value of all shares held in an individual</u>
18 <u>investment fund or pooled account.</u>
