A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. In addition to other amounts appropriated, the  
6 amount of \$40,277,900, or so much thereof as may be necessary,  
7 is appropriated from the General Revenue Fund to the Department  
8 of Natural Resources for operational expenses of the fiscal  
9 year ending June 30, 2022.

9 establish long-term contracts and permanent conservation  
10 easements in the Illinois River Basin; to fund cost share  
11 assistance to landowners to encourage approved conservation  
12 practices in environmentally sensitive and highly erodible  
13 areas of the Illinois River Basin; and to fund the monitoring  
14 of long-term improvements of these conservation practices as  
15 required in the Memorandum of Agreement between the State of

5 Ecosystem-Based Management for Illinois' Natural Resources.

6           Section 90. The sum of \$25,000, or so much thereof as may  
7 be necessary, is appropriated from the Roadside Monarch Habitat  
8 Fund to the Department of Natural Resources for ordinary and  
9 contingent expenses related to the development, enhancement and  
10 restoration of Monarch butterfly and other pollinator habitats.

11           Section 95. The sum of \$4,500,000, or so much thereof as  
12 may be necessary, is appropriated from the Wildlife and Fish  
13 Fund to the Department of Natural Resources for expenses of  
14 subgrantee payments.

15           Section 100. The sum of \$350,000, or so much thereof as may  
16 be necessary, independently or in cooperation with the Federal  
17 Government or any agency thereof, any municipal corporation,  
18 or political subdivision of the State, or with any public or  
19 private corporation, organization, or individual, is  
20 appropriated to the Department of Natural Resources from the  
21 Federal Title IV Fire Protection Assistance Fund for refunds

1 and for Rural Community Fire Protection Programs.

3 Section 105. The sum of \$6,008,900, or so much thereof may
