1 may the registration fee for electric vehicles exceed 2 registration year. Beginning on January 1, 2020, the registration fee for these vehicles shall be equal to the fee 3 4 set forth in Section 3-806 for motor vehicles of the first 5 division, other than Autocycles, Motorcycles, Motor Driven Cycles, and Pedalcycles. In addition to the registration fees, 6 the Secretary shall assess an additional \$100 per year in lieu 7 of the payment of motor fuel taxes. \$1 of the additional fees 8 shall be deposited into the Secretary of State Special 9 10 Services Fund and the remainder of the additional fees shall 11 be deposited into the Road Fund.

(b) Beginning with the 2023 registration year, upon the 12 request of the vehicle owner, an electric vehicle owner may 13 14 register an electric vehicle with any qualifying registration 15 issued under this Chapter, and an additional \$100 surcharge 16 shall be collected in addition to the applicable registration fee. The \$100 additional fee is to identify the vehicle as an 17 electric vehicle. The \$100 additional fee is an annual, flat 18 19 fee that shall be based on an applicant's new or existing 20 registration year for the vehicle's corresponding weight category. A designation as an electric vehicle under this 21 22 subsection shall not alter a vehicle's registration. Of the additional fees, \$1 shall be deposited into the Secretary of 23 24 State Special Services Fund, and the remainder of the 25 additional fees shall be deposited into the Road Fund. The Secretary shall adopt any rules necessary to implement this 26
