## SYNOPSIS AS INTRODUCED:

Provides that specified amounts are appropriated from the General Revenue Fund to specified units of local government for non-competitively awarded grants to community-based organizations that address violence prevention using a culturally competent approach and that are capable of decreasing violence in the specified representative districts. Provides for the types of prevention, services, and programs the grants shall support. Effective July 1, 2021.

1 AN ACT concerning appropriations.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The following amounts are appropriated from the General Revenue Fund to units of local government as set forth 5 in this Section for non-competitively awarded grants 6 7 community-based organizations that address violence prevention 8 using a culturally competent approach and that are capable of 9 decreasing violence in the specified representative districts. 10 The grants shall support: violence prevention; youth services; 11 after school programming; trauma-informed counseling services; 12 youth work experiences; job readiness training programs; public awareness campaigns; disconnected youth; capacity building; 13 14 grant management, writing, and development; organizational 15 structure and sustainability; street-level outreach; and other 16 priority areas. \$2,000,000, or so much of that amount as may be necessary, 17 18 is appropriated to the Cook County for a grant to an organization 19 based entirely within the 3rd Representative District.
