Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 2. The Reimagining Electric Vehicles in Illinois
- 5 Act is amended by changing Sections 10, 15, 20, 30, and 40 as

- "Advanced battery component" means a component of an
- 14 advanced battery, including materials, enhancements,
- 15 enclosures, anodes, cathodes, electrolytes, cells, and other
- 16 associated technologies that comprise an advanced battery.
- "Agreement" means the agreement between a taxpayer and the
- 18 Department under the provisions of Section 45 of this Act.
- "Applicant" means a taxpayer that (i) operates a business
- 20 in Illinois or is planning to locate a business within the
- 21 State of Illinois and (ii) is engaged in interstate or
- 22 intrastate commerce for the purpose of manufacturing electric
- 23 vehicles, electric vehicle component parts, or electric

vehicle power supply equipment. "Applicant" does not include a taxpayer who closes or substantially reduces by more than 50% operations at one location in the State and relocates substantially the same operation to another location in the State. This does not prohibit a Taxpayer from expanding its operations at another location in the State. This also does not prohibit a Taxpayer from moving its operations from one location in the State to another location in the State for the purpose of expanding the operation, provided that the Department determines that expansion cannot reasonably be accommodated within the municipality or county in which the business is located, or, in the case of a business located in an incorporated area of the county, within the county in which the business is located, after conferring with the chief elected official of the municipality or county and taking into consideration any evidence offered by the municipality or county regarding the ability to accommodate expansion within the municipality or county.

"Battery raw materials" means the raw and processed form of a mineral, metal, chemical, or other material used in an advanced battery component.

"Battery raw materials refining service provider" means a business that operates a facility that filters, sifts, and treats battery raw materials for use in an advanced battery.

"Battery recycling and reuse manufacturer" means a manufacturer that is primarily engaged in the recovery,

retrieval, processing, recycling, or recirculating of battery raw materials for new use in electric vehicle batteries.

"Capital improvements" means the purchase, renovation, rehabilitation, or construction of permanent tangible land, buildings, structures, equipment, and furnishings in an approved project sited in Illinois and expenditures for goods or services that are normally capitalized, including organizational costs and research and development costs incurred in Illinois. For land, buildings, structures, and equipment that are leased, the lease must equal or exceed the term of the agreement, and the cost of the property shall be determined from the present value, using the corporate interest rate prevailing at the time of the application, of the lease payments.

"Credit" means either a "REV Illinois Credit" or a "REV Construction Jobs Credit" agreed to between the Department and applicant under this Act.

"Department" means the Department of Commerce and Economic Opportunity.

"Director" means the Director of Commerce and Economic Opportunity.

"Electric vehicle" means a vehicle that is exclusively powered by and refueled by electricity, including electricity generated through a hydrogen fuel cells or solar technology. "Electric vehicle" does not include hybrid electric vehicles, electric bicycles, or extended-range electric vehicles that

are also equipped with conventional fueled propulsion or auxiliary engines.

"Electric vehicle manufacturer" means a new or existing manufacturer that is primarily focused on reequipping, expanding, or establishing a manufacturing facility in Illinois that produces electric vehicles as defined in this Section.

"Electric vehicle component parts manufacturer" means a new or existing manufacturer that is primarily focused on reequipping, expanding, or establishing a manufacturing facility in Illinois that produces parts or accessories used in electric vehicles advanced battery components or key components that directly support the electric functions of electric vehicles, as defined by this Section, including advanced battery component parts. The changes to this definition of "electric vehicle component parts manufacturer" apply to agreements under this Act that are entered into on or after the effective date of this amendatory Act of the 102nd General Assembly.

"Electric vehicle power supply equipment" means the equipment used specifically for the purpose of delivering electricity to an electric vehicle, including hydrogen fuel cells or solar refueling infrastructure.

"Electric vehicle power supply manufacturer" means a new or existing manufacturer that is focused on reequipping, expanding, or establishing a manufacturing facility in

- Illinois that produces electric vehicle power supply equipment 1
- 2 used for the purpose of delivering electricity to an electric
- vehicle, including hydrogen fuel cell or solar refueling 3
- infrastructure.
- "Energy Transition Area" means a county with less than
- 6 100,000 people or a municipality that contains one or more of
- 7 the following:
- 8 (1) a fossil fuel plant that was retired from service
- 9 or has significant reduced service within 6 years before
- 10 the time of the application or will be retired or have
- 11 service significantly reduced within 6 years following the
- 12 time of the application; or
- 13 (2) a coal mine that was closed or had operations
- 14 significantly reduced within 6 years before the time of
- 15 the application or is anticipated to be closed or have
- 16 operations significantly reduced within 6 years following
- 17 the time of the application.
- "Full-time employee" means an individual who is employed 18
- for consideration for at least 35 hours each week or who 19
- 20 renders any other standard of service generally accepted by
- 21 industry custom or practice as full-time employment. An
- 22 individual for whom a W-2 is issued by a Professional Employer
- 23 Organization (PEO) is a full-time employee if employed in the
- 24 service of the applicant for consideration for at least 35
- 25 hours each week.
- 26 "Incremental income tax" means the total amount withheld

- during the taxable year from the compensation of new employees 1
- 2 and, if applicable, retained employees under Article 7 of the
- 3 Illinois Income Tax Act arising from employment at a project
- that is the subject of an agreement. 4
- 5 "Institution of higher education" or "institution" means
- 6 any accredited public or private university, college,
- 7 community college, business, technical, or vocational school,
- or other accredited educational institution offering degrees 8
- 9 and instruction beyond the secondary school level.
- 10 "Minority person" means a minority person as defined in
- 11 the Business Enterprise for Minorities, Women, and Persons
- 12 with Disabilities Act.
- 13 "New employee" means a newly-hired full-time employee
- 14 employed to work at the project site and whose work is directly
- 15 related to the project.
- 16 "Noncompliance date" means, in the case of a taxpayer that
- 17 is not complying with the requirements of the agreement or the
- provisions of this Act, the day following the last date upon 18
- which the taxpayer was in compliance with the requirements of 19
- 20 the agreement and the provisions of this Act, as determined by
- the Director, pursuant to Section 70. 21
- 22 "Pass-through entity" means an entity that is exempt from
- 23 the tax under subsection (b) or (c) of Section 205 of the
- Illinois Income Tax Act. 24
- "Placed in service" means the state or condition of 25
- 26 readiness, availability for a specifically assigned function,

- 1 and the facility is constructed and ready to conduct its
- 2 facility operations to manufacture goods.
- 3 "Professional employer organization" (PEO) means an
- 4 employee leasing company, as defined in Section 206.1 of the
- 5 Illinois Unemployment Insurance Act.
- 6 "Program" means the Reimagining Electric Vehicles in
- 7 Illinois Program (the REV Illinois Program) established in
- 8 this Act.
- 9 "Project" or "REV Illinois Project" means a for-profit
- 10 economic development activity for the manufacture of electric
- 11 vehicles, electric vehicle component parts, or electric
- 12 vehicle power supply equipment which is designated by the
- Department as a REV Illinois Project and is the subject of an
- 14 agreement.
- "Recycling facility" means a location at which the
- 16 taxpayer disposes of batteries and other component parts in
- 17 manufacturing of electric vehicles, electric vehicle component
- 18 parts, or electric vehicle power supply equipment.
- 19 "Related member" means a person that, with respect to the
- 20 taxpayer during any portion of the taxable year, is any one of
- 21 the following:
- 22 (1) An individual stockholder, if the stockholder and
- 23 the members of the stockholder's family (as defined in
- 24 Section 318 of the Internal Revenue Code) own directly,
- indirectly, beneficially, or constructively, in the
- aggregate, at least 50% of the value of the taxpayer's

outstanding stock.

- (2) A partnership, estate, trust and any partner or beneficiary, if the partnership, estate, or trust, and its partners or beneficiaries own directly, indirectly, beneficially, or constructively, in the aggregate, at least 50% of the profits, capital, stock, or value of the taxpayer.
- (3) A corporation, and any party related to the corporation in a manner that would require an attribution of stock from the corporation under the attribution rules of Section 318 of the Internal Revenue Code, if the Taxpayer owns directly, indirectly, beneficially, or constructively at least 50% of the value of the corporation's outstanding stock.
- (4) A corporation and any party related to that corporation in a manner that would require an attribution of stock from the corporation to the party or from the party to the corporation under the attribution rules of Section 318 of the Internal Revenue Code, if the corporation and all such related parties own in the aggregate at least 50% of the profits, capital, stock, or value of the taxpayer.
- (5) A person to or from whom there is an attribution of stock ownership in accordance with Section 1563(e) of the Internal Revenue Code, except, for purposes of determining whether a person is a related member under this paragraph,

20% shall be substituted for 5% wherever 5% appears in Section 1563(e) of the Internal Revenue Code.

"Retained employee" means a full-time employee employed by the taxpayer prior to the term of the Agreement who continues to be employed during the term of the agreement whose job duties are directly and substantially related to the project. For purposes of this definition, "directly and substantially related to the project" means at least two thirds of employee's job duties must be directly related to the project and the employee must devote at least two thirds of his or her time to the project. The term "retained employee" does not include any individual who has a direct or an indirect ownership interest of at least 5% in the profits, equity, capital, or value of the taxpayer or a child, grandchild, parent, or spouse, other than a spouse who is legally separated from the individual, of any individual who has a direct or indirect ownership of at least 5% in the profits, equity, capital, or value of the taxpayer. The changes to this definition of "retained employee" apply to agreements for credits under this Act that are entered into on or after the effective date of this amendatory Act of the 102nd General Assembly.

"REV Illinois credit" means a credit agreed to between the Department and the applicant under this Act that is based on the incremental income tax attributable to new employees and, if applicable, retained employees, and on training costs for

such employees at the applicant's project.

"REV construction jobs credit" means a credit agreed to between the Department and the applicant under this Act that is based on the incremental income tax attributable to construction wages paid in connection with construction of the project facilities.

"Statewide baseline" means the total number of full-time employees of the applicant and any related member employed by such entities at the time of application for incentives under this Act.

"Taxpayer" means an individual, corporation, partnership, or other entity that has a legal obligation to pay Illinois income taxes and file an Illinois income tax return.

"Training costs" means costs incurred to upgrade the technological skills of full-time employees in Illinois and includes: curriculum development; training materials (including scrap product costs); trainee domestic travel expenses; instructor costs (including wages, fringe benefits, tuition and domestic travel expenses); rent, purchase or lease of training equipment; and other usual and customary training costs. "Training costs" do not include costs associated with travel outside the United States (unless the Taxpayer receives prior written approval for the travel by the Director based on a showing of substantial need or other proof the training is not reasonably available within the United States), wages and fringe benefits of employees during periods of training, or

- 1 administrative cost related to full-time employees of the
- 2 taxpayer.
- 3 "Underserved area" means any geographic areas as defined
- 4 in Section 5-5 of the Economic Development for a Growing
- 5 Economy Tax Credit Act.
- 6 (Source: P.A. 102-669, eff. 11-16-21; 102-700, eff. 4-19-22.)
- 7 (20 ILCS 686/15)
- 8 Sec. 15. Powers of the Department. The Department, in 9 addition to those powers granted under the Civil 10 Administrative Code of Illinois, is granted and shall have all 11 the powers necessary or convenient to administer the program 12 under this Act and to carry out and effectuate the purposes and
- provisions of this Act, including, but not limited to, the
- 14 power and authority to:

- 22 (a) The Reimagining Electric Vehicles in Illinois (REV Illinois) Program is hereby established and shall be administered by the Department. The Program will provide financial incentives to any one or more of the following: (1)

- eligible manufacturers of electric vehicles, electric vehicle 1
- 2 component parts, and electric vehicle power supply equipment;
- 3 (2) battery recycling and reuse manufacturers; or (3) battery
- raw materials refining service providers.
- 5 (b) Any taxpayer planning a project to be located in Illinois may request consideration for designation of its

- (A) make an investment of at least \$100,000,000 in capital improvements at the project site;
- (B) to be placed in service within the State within a 60-month period after approval of the application; and
- (C) create the lesser of 75 new full-time employee jobs or new full-time employee jobs equivalent to 10% of the Statewide baseline applicable to the taxpayer and any related member at the time of application.
- (d) For agreements entered into prior to April 19, 2022 (the effective date of Public Act 102-700) this amendatory Act of the 102nd General Assembly, for any applicant creating the full-time employee jobs noted in subsection (c), those jobs must have a total compensation equal to or greater than 120% of the average wage paid to full-time employees in the county where the project is located, as determined by the U.S. Bureau of Labor Statistics. For agreements entered into on or after April 19, 2022 (the effective date of Public Act 102-700) this amendatory Act of the 102nd General Assembly, for any

applicant creating the full-time employee jobs noted in subsection (c), those jobs must have a compensation equal to or greater than 120% of the average wage paid to full-time employees in a similar position within an occupational group in the county where the project is located, as determined by

the <u>Department</u> U.S. Bureau of Labor Statistics.

- 7 (e) For any applicant, within 24 months after being placed 8 in service, it must certify to the Department that it is carbon 9 neutral or has attained certification under one of more of the 10 following green building standards:
 - (1) BREEAM for New Construction or BREEAM In-Use;
- 12 (2) ENERGY STAR;
- 13 (3) Envision;
- 14 (4) ISO 50001 energy management;
- 15 (5) LEED for Building Design and Construction or LEED for Building Operations and Maintenance;
 - (6) Green Globes for New Construction or Green Globes for Existing Buildings; or
- 19 (7) UL 3223.
- (f) Each applicant must outline its hiring plan and commitment to recruit and hire full-time employee positions at the project site. The hiring plan may include a partnership with an institution of higher education to provide internships, including, but not limited to, internships supported by the Clean Jobs Workforce Network Program, or full-time permanent employment for students at the project

Additionally, the applicant may create or utilize participants from apprenticeship programs that are approved by and registered with the United States Department of Labor's Bureau of Apprenticeship and Training. The applicant may apply for apprenticeship education expense credits in accordance with the provisions set forth in 14 Ill. Adm. Admin. Code 522. Each applicant is required to report annually, on or before April 15, on the diversity of its workforce in accordance with Section 50 of this Act. For existing facilities of applicants under paragraph (3) of subsection (b) above, if the taxpayer expects a reduction in force due to its transition to manufacturing electric vehicle, electric vehicle component parts, or electric vehicle power supply equipment, the plan submitted under this Section must outline the taxpayer's plan to assist with retraining its workforce aligned with the taxpayer's adoption of new technologies and anticipated efforts to retrain employees through employment opportunities within the taxpayer's workforce.

- (g) Each applicant must demonstrate a contractual or other relationship with a recycling facility, or demonstrate its own recycling capabilities, at the time of application and report annually a continuing contractual or other relationship with a recycling facility and the percentage of batteries used in electric vehicles recycled throughout the term of the agreement.
 - (h) A taxpayer may not enter into more than one agreement

under this Act with respect to a single address or location for the same period of time. Also, a taxpayer may not enter into an agreement under this Act with respect to a single address or location for the same period of time for which the taxpayer currently holds an active agreement under the Economic Development for a Growing Economy Tax Credit Act. provision does not preclude the applicant from entering into an additional agreement after the expiration or voluntary termination of an earlier agreement under this Act or under the Economic Development for a Growing Economy Tax Credit Act to the extent that the taxpayer's application otherwise satisfies the terms and conditions of this Act and is approved by the Department. An applicant with an existing agreement under the Economic Development for a Growing Economy Tax Credit Act may submit an application for an agreement under this Act after it terminates any existing agreement under the Economic Development for a Growing Economy Tax Credit Act with respect to the same address or location. If a project that is subject to an existing agreement under the Economic Development for a Growing Economy Tax Credit Act meets the requirements to be designated as a REV Illinois project under this Act, including for actions undertaken prior to the effective date of this Act, the taxpayer that is subject to that existing agreement under the Economic Development for a Growing Economy Tax Credit Act may apply to the Department to amend the agreement to allow the project to become a

REV Illinois Credits awarded may include credit earned for incremental income tax withheld and training costs incurred by the taxpayer beginning on or after January 1, 2022. Credits so earned and certified by the Department may be applied against the tax imposed by subsections (a) and (b) of Section 201 of the Illinois Income Tax Act for taxable years beginning on or after January 1, 2025.

(c) REV Construction Jobs Credit. For construction wages associated with a project that qualified for a REV Illinois Credit under subsection (b), the taxpayer may receive a tax credit against the tax imposed under subsections (a) and (b) of Section 201 of the Illinois Income Tax Act in an amount equal to 50% of the incremental income tax attributable to construction wages paid in connection with construction of the project facilities, as a jobs credit for workers hired to construct the project.

The REV Construction Jobs Credit may not exceed 75% of the amount of the incremental income tax attributable to construction wages paid in connection with construction of the project facilities if the project is in an underserved area or an energy transition area.

- (d) The Department shall certify to the Department of Revenue: (1) the identity of Taxpayers that are eligible for the REV Illinois Credit and REV Construction Jobs Credit; (2) the amount of the REV Illinois Credits and REV Construction Jobs Credits awarded in each calendar year; and (3) the amount of the REV Illinois Credit and REV Construction Jobs Credit claimed in each calendar year. REV Illinois Credits awarded may include credit earned for Incremental Income Tax withheld and Training Costs incurred by the Taxpayer beginning on or after January 1, 2022. Credits so earned and certified by the Department may be applied against the tax imposed by Section 201(a) and (b) of the Illinois Income Tax Act for taxable years beginning on or after January 1, 2025.
 - (e) Applicants seeking certification for a tax credits related to the construction of the project facilities in the State shall require the contractor to enter into a project labor agreement that conforms with the Project Labor Agreements Act.
 - (f) Any applicant issued a certificate for a tax credit or tax exemption under this Act must annually report to the Department the total project tax benefits received. Reports are due no later than May 31 of each year and shall cover the previous calendar year. The first report is for the 2022 calendar year and is due no later than May 31, 2023.

(J) With the exception of any amounts subtracted under subparagraph (G), an amount equal to the sum of all amounts disallowed as deductions by (i) Sections 171(a)(2) and 265(a)(2) of the Internal Revenue Code, and all amounts of expenses allocable to interest and disallowed as deductions by Section 265(a)(1) of the Internal Revenue Code; and (ii) for taxable years ending on after August 13, 1999, Sections or 265, 280C, and 832(b)(5)(B)(i) 171(a)(2), Internal Revenue Code, plus, (iii) for taxable years ending on or after December 31, 2011. 45G(e)(3) of the Internal Revenue Code and, taxable years ending on or after December 31, 2008, any amount included in gross income under Section 87 of the Internal Revenue Code; the provisions of this subparagraph are exempt from the provisions of Section 250;

(K) An amount equal to those dividends included in such total which were paid by a corporation which conducts business operations in a River Edge Redevelopment Zone or zones created under the River Edge Redevelopment Zone Act and conducts substantially

all of its operations from a River Edge Redevelopment Zone or zones. This subparagraph (K) is exempt from the provisions of Section 250;

- (L) An amount equal to any contribution made to a job training project established pursuant to the Real Property Tax Increment Allocation Redevelopment Act;
- (M) An amount equal to those dividends included in such total that were paid by a corporation that conducts business operations in a federally designated Foreign Trade Zone or Sub-Zone and that is designated a High Impact Business located in Illinois; provided that dividends eligible for the deduction provided in subparagraph (K) of paragraph (2) of this subsection shall not be eligible for the deduction provided under this subparagraph (M);

The aggregate amount deducted under this subparagraph in all taxable years for any one piece of property may not exceed the amount of the bonus depreciation deduction taken on that property on the taxpayer's federal income tax return under subsection (k) of Section 168 of the Internal Revenue Code. In the case of a cooperative corporation or association, the taxable income of such organization determined in accordance with provisions of Section 1381 through 1388 the Internal Revenue Code, but without regard to prohibition against offsetting losses from patronage activities against income from nonpatronage activities; except that a cooperative corporation or association may make an election to follow its federal income tax treatment of patronage losses and nonpatronage losses. "Illinois production spending" means any and all expenses directly or indirectly incurred relating to an accredited theater production presented in any qualified production facility of the applicant, including, but not limited to, expenditures for:

efficiently locate outside of the State, (ii) at least one other state or nation could be considered for the production, (iii) the receipt of the tax award credit is a major factor in the decision of the applicant, presenter, production owner or licensee as to where the production will be presented and that without the tax credit award the applicant likely would not create or retain jobs in Illinois, or (iv) receipt of the tax credit award is essential to the applicant's decision to create or retain new jobs in the State; and

- (6) the tax credit award will result in an overall positive impact to the State, as determined by the Department using the best available data.
- (b) If any of the provisions in this Section conflict with any existing collective bargaining agreements, the terms and conditions of those collective bargaining agreements shall control.
- (c) The Department shall act expeditiously regarding approval of applications for accredited theater production certificates so as to accommodate the pre-production work, booking, commencement of ticket sales, determination of performance dates, load in, and other matters relating to the live theater productions for which approval is sought.

Sec. 21-25. Due dates; accelerated billing in counties of 3,000,000 or more. Except as hereinafter provided and as provided in Section 21-40, in counties with 3,000,000 or more inhabitants in which the accelerated method of billing and paying taxes provided for in Section 21-30 is in effect, the estimated first installment of unpaid taxes shall be deemed delinquent and shall bear interest after March 1 at the rate of $1 \frac{1}{2}$ per month or portion thereof until paid or forfeited. For tax year 2010, the estimated first installment of unpaid taxes shall be deemed delinquent and shall bear interest after April 1 at the rate of 1.5% per month or portion thereof until paid or forfeited. For tax year 2022, the estimated first installment of unpaid taxes shall be deemed delinquent and shall bear interest after April 1, 2023 at the rate of 1.5% per month or portion thereof until paid or forfeited. For all tax years, the second installment of unpaid taxes shall be deemed delinquent and shall bear interest after August 1 annually at the same interest rate until paid or forfeited. Notwithstanding any other provision of law, if a taxpayer owes an arrearage of taxes due to an administrative error, and if the county collector sends a separate bill for that arrearage as provided in Section 14-41, then any part of the arrearage of taxes that remains unpaid on the day after the due date

specified on that tax bill shall be deemed delinquent and shall bear interest after that date at the rate of 1 1/2% per month or portion thereof.

If the county board elects by ordinance adopted prior to July 1 of a levy year to provide for taxes to be paid in 4 installments, each installment for that levy year and each subsequent year shall be deemed delinquent and shall begin to bear interest 30 days after the date specified by the ordinance for mailing bills, at the rate of 1 1/2% per month or portion thereof, until paid or forfeited.

Payment received by mail and postmarked on or before the required due date is not delinquent.

Taxes levied on homestead property in which a member of the National Guard or reserves of the armed forces of the United States who was called to active duty on or after August 1, 1990, and who has an ownership interest, shall not be deemed delinquent and no interest shall accrue or be charged as a penalty on such taxes due and payable in 1991 or 1992 until one year after that member returns to civilian status.

If an Illinois resident who is a member of the Illinois National Guard or a reserve component of the armed forces of the United States and who has an ownership interest in property taxed under this Act is called to active duty for deployment outside the continental United States and is on active duty on the due date of any installment of taxes due under this Act, he or she shall not be deemed delinquent in the

payment of the installment and no interest shall accrue or be 1 2 charged as a penalty on the installment until 180 days after that member returns to civilian status. To be deemed not 3 delinquent in the payment of an installment of taxes and any 5 interest on that installment, the reservist or quardsperson must make a reasonable effort to notify the county clerk and 6 the county collector of his or her activation to active duty 7 8 and must notify the county clerk and the county collector 9 within 180 days after his or her deactivation and provide verification of the date of his or her deactivation. An 10 11 installment of property taxes on the property of any reservist 12 or guardsperson who fails to provide timely notice and 13 verification of deactivation to the county clerk is subject to interest and penalties as delinquent taxes under this Code 14 15 from the date of deactivation.
