A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, are appropriated to the
7 Illinois State Police for the following purposes:

16 Section 10. The sum of \$4,000,000, or so much thereof as
 17 may be necessary, is appropriated from the State Asset
 18 Forfeiture Fund to the Illinois State Police for payment of
 19 their expenditures as outlined in the Illinois Drug Asset
 20 Forfeiture Procedure Act, the Cannabis Control Act, the
 21 Controlled Substances Act and the Environmental Safety Act.

22 Section 15. The sum of \$2,500,000, or so much thereof as
 23 may be necessary, is appropriated from the Federal Asset

1 Forfeiture Fund to the Illinois State Police for payment of
 2 their expenditures in accordance with the Federal Equitable
 3 Sharing Guidelines.

4 Section 20. The sum of \$2,000,000, or so much thereof as
 5 may be necessary, is appropriated to the Illinois State Police,
 6 Division of Justice Services, from the Money Laundering Asset
 7 Recovery Fund for the ordinary and contingent expenses incurred
 8 by the Illinois State Police.

9 Section 25. The sum of \$1,000,000, or so much thereof as
 10 may be necessary, is appropriated from the LEADS Maintenance
 11 Fund to the Illinois State Police, Division of Justice
 12 Services, for expenses related to the LEADS System.

13 Section 30. The following named amounts, or so much thereof
 14 as may be necessary, respectively, are appropriated to the
 15 Illinois State Police for the following purposes:

20 Section 35. The following amount, or so much thereof as
 21 may be necessary for objects and purposes hereinafter named,
 22 is appropriated from the Drug Traffic Prevention Fund to the
 23 Illinois State Police, Division of Operations, pursuant to the
 24 provisions of the "Intergovernmental Drug Laws Enforcement Act"

1 for Grants to Metropolitan Enforcement Groups.

2 For Grants to Metropolitan Enforcement Groups:

3 Payable from the Drug Traffic

4 Prevention Fund500,000

5 Section 40. The sum of \$18,000,000, or so much thereof as
6 may be necessary, is appropriated from the State Police
7 Whistleblower Reward and Protection Fund to the Illinois State
8 Police for payment of their expenditures for state law
9 enforcement purposes in accordance with the State Whistleblower
10 Protection Act.

11 Section 45. The sum of \$36,000,000, or so much thereof as
12 may be necessary, is appropriated from the State Police
13 Operations Assistance Fund to the Illinois State Police for the
14 ordinary and contingent expenses incurred by the Illinois State
15 Police.

16 Section 47. The sum of \$2,000,000, or so much thereof as
17 may be necessary, is appropriated from the State Police
18 Operations Assistance Fund to the Illinois State Police for the
19 ordinary and contingent expenses of the Safe2Help Program.

20 Section 50. The sum of \$100,000, or so much thereof as may
21 be necessary, is appropriated from the Medicaid Fraud and Abuse

1 Prevention Fund to the Illinois State Police, Division of
2 Operations, for the detection, investigation or prosecution of
3 recipient or vendor fraud.

4 Section 55. The sum of \$13,000,000, or so much thereof as
5 may be necessary, is appropriated from the State Police Law
6 Enforcement Administration Fund to the Illinois State Police,
7 Division of Operations, for all costs associated with a cadet
8 program for the Illinois State Police.

9 Section 60. The sum of \$2,000,000, or so much thereof as
10 may be necessary, is appropriated from the Scott's Law Fund to
11 the Illinois State Police for the ordinary and contingent
12 expenses incurred by the Illinois State Police.

13 Section 65. The sum of \$30,000,000, or so much thereof as
14 may be necessary, is appropriated from the Illinois State
15 Police Federal Projects Fund to the Illinois State Police for
16 current and prior year expenses relating to federal awards and
17 grants.

18 Section 70. The sum of \$6,000,000, or so much thereof as
19 may be necessary, is appropriated from the State Police
20 Training and Academy Fund to the Illinois State Police for
21 expenses related to State Police Training.

1 Section 75. The following named amounts, or so much thereof
 2 as may be necessary, respectively, are appropriated to the
 3 Illinois State Police for the following purposes:

1 Section 80. The sum of \$2,250,000, or so much thereof as
2 may be necessary, is appropriated to the Illinois State Police,
3 Division of Forensic Services and Identification, from the
4 Mental Health Reporting Fund for expenses as outlined in the
5 Firearm Concealed Carry Act and the Firearm Owners
6 Identification Card Act.

7 Section 85. The sum of \$29,000,000, or so much thereof as
8 may be necessary, is appropriated to the Illinois State Police
9 from the State Police Firearm Services Fund for expenses as
10 outlined in the Firearm Concealed Carry Act and the Firearm
11 Owners Identification Card Act.

12 Section 90. The sum of \$62,800, or so much thereof as may
13 be necessary, is appropriated to the Illinois State Police,
14 Division of Internal Investigation, from the General Revenue
15 Fund for the ordinary and contingent expenses incurred while
16 operating the Nursing Home Identified Offender Program.

17 Section 95. The sum of \$230,000,000, or so much thereof
18 as may be necessary, is appropriated from the Statewide 9-1-1
19 Fund to the Illinois State Police, Division of Justice
20 Services, for costs pursuant to the Emergency Telephone System
21 Act.

1 Section 100. The sum of \$2,000,000, or so much thereof as
2 may be necessary, is appropriated from the State Police
3 Revocation Enforcement Fund to the Illinois State Police, for
4 grants to law enforcement agency task forces for participating
5 in programs to help reduce crime.

6 Section 999. Effective Date. This Act takes effect July
7 1, 2022.
