## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 11 Section 45. The sum of \$36,000,000, or so much thereof as

- 13 Operations Assistance Fund to the Illinois State Police for the
- ordinary and contingent expenses incurred by the Illinois State
- 15 Police.
- Section 47. The sum of \$2,000,000, or so much thereof as
- 17 may be necessary, is appropriated from the State Police
- Operations Assistance Fund to the Illinois State Police for the
- ordinary and contingent expenses of the Safe2Help Program.
- Section 50. The sum of \$100,000, or so much thereof as may
- 21 be necessary, is appropriated from the Medicaid Fraud and Abuse

- 1 Prevention Fund to the Illinois State Police, Division of
- 2 Operations, for the detection, investigation or prosecution of
- 3 recipient or vendor fraud.
- 4 Section 55. The sum of \$13,000,000, or so much thereof as
- 5 may be necessary, is appropriated from the State Police Law
- 6 Enforcement Administration Fund to the Illinois State Police,
- 7 Division of Operations, for all costs associated with a cadet
- 8 program for the Illinois State Police.
- 9 Section 60. The sum of \$2,000,000, or so much thereof as
- 10 may be necessary, is appropriated from the Scott's Law Fund to
- 11 the Illinois State Police for the ordinary and contingent
- 12 expenses incurred by the Illinois State Police.
- 13 Section 65. The sum of \$30,000,000, or so much thereof as
- 14 may be necessary, is appropriated from the Illinois State
- 15 Police Federal Projects Fund to the Illinois State Police for
- 16 current and prior year expenses relating to federal awards and
- 17 grants.
- Section 70. The sum of \$6,000,000, or so much thereof as
- 19 may be necessary, is appropriated from the State Police
- 20 Training and Academy Fund to the Illinois State Police for
- 21 expenses related to State Police Training.

- 1 Section 80. The sum of \$2,250,000, or so much thereof as
- 2 may be necessary, is appropriated to the Illinois State Police,
- 3 Division of Forensic Services and Identification, from the
- 4 Mental Health Reporting Fund for expenses as outlined in the
- 5 Firearm Concealed Carry Act and the Firearm Owners
- 6 Identification Card Act.
- 7 Section 85. The sum of \$29,000,000, or so much thereof as
- 8 may be necessary, is appropriated to the Illinois State Police
- 9 from the State Police Firearm Services Fund for expenses as
- 10 outlined in the Firearm Concealed Carry Act and the Firearm
- 11 Owners Identification Card Act.
- 12 Section 90. The sum of \$62,800, or so much thereof as may
- 13 be necessary, is appropriated to the Illinois State Police,
- 14 Division of Internal Investigation, from the General Revenue
- 15 Fund for the ordinary and contingent expenses incurred while
- operating the Nursing Home Identified Offender Program.
- Section 95. The sum of \$230,000,000, or so much thereof
- as may be necessary, is appropriated from the Statewide 9-1-1
- 19 Fund to the Illinois State Police, Division of Justice
- 20 Services, for costs pursuant to the Emergency Telephone System
- 21 Act.

- Section 100. The sum of \$2,000,000, or so much thereof as
- 2 may be necessary, is appropriated from the State Police
- 3 Revocation Enforcement Fund to the Illinois State Police, for
- 4 grants to law enforcement agency task forces for participating
- 5 in programs to help reduce crime.
- 6 Section 999. Effective Date. This Act takes effect July
- 7 1, 2022.
