### SYNOPSIS AS INTRODUCED:

Makes appropriations to Southern Illinois University and its Board of Trustees for operational and program expenses of Southern Illinois University for the fiscal year beginning July 1, 2022. Appropriates \$550,000 from the General Revenue Fund to the Department of Human Services for a grant to the Southern Illinois University Center for Rural Health and costs associated with providing mental health and support services to farm owners. Effective July 1, 2022.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The sum of \$206,562,900, or so much thereof as  
5 may be necessary, is appropriated from the Education Assistance  
6 Fund to the Board of Trustees of Southern Illinois University  
7 to meet its operational expenses for the fiscal year ending  
8 June 30, 2023.

9 Section 10. The sum of \$62,800, or so much thereof as may  
10 be necessary, is appropriated from the General Revenue Fund to  
11 Southern Illinois University for costs associated with the  
12 Daily Egyptian Newspaper.

13 Section 15. The sum of \$1,000,000, or so much thereof as  
14 may be necessary, is appropriated from the General Revenue Fund  
15 to the Board of Trustees of Southern Illinois University for  
16 costs associated with the National Corn-to-Ethanol Research  
17 Center and ethanol research grants.

18 Section 20. The sum of \$285,000, or so much thereof as may  
19 be necessary, is appropriated from the General Revenue Fund to  
20 the Board of Trustees of Southern Illinois University to meet

1 operational expenses for the SIU System Institute for Rural  
2 Health.

3 Section 25. The sum of \$266,600, or so much thereof as may  
4 be necessary, is appropriated from the General Revenue Fund to  
5 the Board of Trustees of Southern Illinois University to meet  
6 operational expenses for the SIU System Office of Community  
7 Engagement.

8 Section 30. The sum of \$1,076,800, or so much thereof as  
9 may be necessary, is appropriated from the Education Assistance  
10 Fund to the Board of Trustees of Southern Illinois University  
11 for costs associated with the Simmons Cooper Cancer Center.

12 Section 35. The sum of \$17,000, or so much thereof as may  
13 be necessary, is appropriated from the State College and  
14 University Trust Fund to the Board of Trustees of Southern  
15 Illinois University for scholarship grant awards.

16 Section 40. The sum of \$1,250,000, or so much thereof as  
17 may be necessary, is appropriated from the General Professions  
18 Dedicated Fund to the Board of Trustees of Southern Illinois  
19 University for costs associated with the development, support,  
20 or administration of pharmacy practice education or training  
21 programs at the Edwardsville campus.

1           Section 45. The sum of \$550,000, or so much thereof as may  
2   be necessary, is appropriated from the General Revenue Fund to  
3   the Department of Human Services for a grant to the Southern  
4   Illinois University Center for Rural Health and costs  
5   associated with providing mental health and support services  
6   to farm owners.

7           Section 99. Effective date. This Act takes effect July 1,  
8   2022.
