A BILL FOR

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Toll Highway Act is amended by changing
5 Section 3 as follows:

6 (605 ILCS 10/3) (from Ch. 121, par. 100-3)

7 Sec. 3. There is hereby created an Authority to be known as
8 The ~~The~~ Illinois State Toll Highway Authority, which is hereby
9 constituted an instrumentality and an administrative agency of
10 the State of Illinois. The said Authority shall consist of 11
11 directors; the Governor and the Secretary of the Department of
12 Transportation, ex officio, and 9 directors appointed by the
13 Governor with the advice and consent of the Senate, from the
14 State at large, which said directors and their successors are
15 hereby authorized to carry out the provisions of this Act, and
16 to exercise the powers herein conferred. Of the 9 directors
17 appointed by the Governor, no more than 5 shall be members of
18 the same political party.

19 Notwithstanding any provision of law to the contrary, the
20 term of office of each director of the Authority serving on the
21 effective date of this amendatory Act of the 100th General
22 Assembly, other than the Governor and the Secretary of the
23 Department of Transportation, is abolished and a vacancy in

1 each office is created on the effective date of this
2 amendatory Act of the 100th General Assembly. The Governor
3 shall appoint directors to the Authority for the vacancies
4 created under this amendatory Act of the 100th General
5 Assembly by February 28, 2019. Directors whose terms are
6 abolished under this amendatory Act of the 100th General
7 Assembly shall be eligible for reappointment.

8 Vacancies shall be filled for the unexpired term in the
9 same manner as original appointments. All appointments shall
10 be in writing and filed with the Secretary of State as a public
11 record. It is the intention of this section that the
12 Governor's appointments shall be made with due consideration
13 to the location of proposed toll highway routes so that
14 maximum geographic representation from the areas served by
15 said toll highway routes may be accomplished insofar as
16 practicable. The said Authority shall have the power to
17 contract and be contracted with, to acquire, hold and convey
18 personal and real property or any interest therein including
19 rights of way, franchises and easements; to have and use a
20 common seal, and to alter the same at will; to make and
21 establish resolutions, by-laws, rules, rates and regulations,
22 and to alter or repeal the same as the Authority shall deem
23 necessary and expedient for the construction, operation,
24 relocation, regulation and maintenance of a system of toll
25 highways within and through the State of Illinois.

26 Appointment of the additional directors provided for by

1 this amendatory Act of 1980 shall be made within 30 days after
2 the effective date of this amendatory Act of 1980.
