

## 102ND GENERAL ASSEMBLY State of Illinois 2021 and 2022 SB1539

Introduced 2/26/2021, by Sen. Antonio Muñoz

## SYNOPSIS AS INTRODUCED:

30 ILCS 500/1-35 30 ILCS 500/20-170 new 330 ILCS 21/65

Amends the Illinois Procurement Code. Provides that any contract for procurements entered into under the Quincy Veterans' Home Rehabilitation and Rebuilding Act and executed prior to the repeal of that Act shall continue in full force and effect after the repeal of that Act and until as otherwise dictated by the terms of the contract. Extends the repeal of a Section concerning the application of the Code to the Quincy Veterans' Home. Makes conforming changes. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Procurement Code is amended by changing Section 1-35 and by adding Section 20-170 as follows:
- 6 (30 ILCS 500/1-35)
- 7 (Section scheduled to be repealed on July 17, 2021)
- 8 Sec. 1-35. Application to Quincy Veterans' Home. This
- 9 Code does not apply to any procurements related to the
- 10 renovation, restoration, rehabilitation, or rebuilding of the
- 11 Quincy Veterans' Home under the Quincy Veterans' Home
- 12 Rehabilitation and Rebuilding Act, provided that the process
- shall be conducted in a manner substantially in accordance
- 14 with the requirements of the following Sections of  $\underline{\text{this}}$   $\underline{\text{the}}$
- 15 <u>Illinois Procurement</u> Code: 20-160, 25-60, 30-22, 50-5, 50-10,
- 16 50-10.5, 50-12, 50-13, 50-15, 50-20, 50-21, 50-35, 50-36,
- 17 50-37, 50-38, and 50-50; however, for Section 50-35,
- 18 compliance shall apply only to contracts or subcontracts over
- 19 \$100,000.
- This Section is repealed 5 + 3 years after becoming law. The
- 21 repeal of this Section shall not apply to contracts for
- 22 procurements under the Quincy Veterans' Home Rehabilitation
- and Rebuilding Act executed prior to the repeal date.

- 3 Sec. 20-170. Quincy Veterans' Home rehabilitation and
- 4 rebuilding contracts. Notwithstanding any provision of law to
- 5 the contrary, any contract for procurements entered into under
- 6 the Quincy Veterans' Home Rehabilitation and Rebuilding Act
- 7 and executed prior to the repeal of that Act shall continue in
- 8 full force and effect after the repeal of that Act and until as
- 9 otherwise dictated by the terms of the contract.
- 10 Section 10. The Quincy Veterans' Home Rehabilitation and
- 11 Rebuilding Act is amended by changing Section 65 as follows:
- 12 (330 ILCS 21/65)
- 13 (Section scheduled to be repealed on July 17, 2023)
- 14 Sec. 65. Repealer. This Act is repealed 5 years after
- 15 becoming law. The repeal of this Act shall not apply to
- 16 contracts for procurements under this Act executed prior to
- 17 the repeal date.

- 19 Section 99. Effective date. This Act takes effect upon
- 20 becoming law.
