1 AMENDMENT TO SENATE BILL 2803

2 AMENDMENT NO. _____. Amend Senate Bill 2803, by replacing
3 everything after the enacting clause with the following:

4 "ARTICLE 1

5 Section 1. "AN ACT concerning appropriations", Public Act
6 102-0017, certified June 17, 2021, is amended by adding
7 Sections 80, 85, 90, 95, 100, and 105 to Article 35 as follows:

8 (P.A. 102-0017, Article 35, Section 80, new)

9 Sec. 80. The amount of \$300,000,000, or so much thereof
10 as may be necessary, is appropriated from the General Revenue
11 Fund to the Office of the State Comptroller for deposit into
12 the Pension Stabilization Fund.

1 (P.A. 102-0017, Article 35, Section 85, new)

2 Sec. 85. The amount of \$680,400, or so much thereof as may
3 be necessary, is appropriated from the Pension Stabilization
4 Fund to the Office of the State Comptroller for funding the
5 unfunded liabilities of the General Assembly Retirement System.
6 Amounts appropriated under this Section shall be in addition
7 to, and not in lieu of, any State contributions required under
8 Section 2-124 of the Illinois Pension Code.

9 (P.A. 102-0017, Article 35, Section 90, new)

10 Sec. 90. The amount of \$3,571,000, or so much thereof as
11 may be necessary, is appropriated from the Pension
12 Stabilization Fund to the Office of the State Comptroller for
13 funding the unfunded liabilities of the Judges Retirement
14 System. Amounts appropriated under this Section shall be in
15 addition to, and not in lieu of, any State contributions
16 required under Section 18-131 of the Illinois Pension Code.

17 (P.A. 102-0017, Article 35, Section 95, new)

18 Sec. 95. The amount of \$64,786,400, or so much thereof as
19 may be necessary, is appropriated from the Pension
20 Stabilization Fund to the Office of the State Comptroller for
21 funding the unfunded liabilities of the State Employees'
22 Retirement System. Amounts appropriated under this Section
23 shall be in addition to, and not in lieu of, any State

1 contributions required under Section 14-131 of the Illinois
2 Pension Code.

3 (P.A. 102-0017, Article 35, Section 100, new)

4 Sec. 100. The amount of \$172,823,300, or so much thereof
5 as may be necessary, is appropriated from the Pension
6 Stabilization Fund to the Office of the State Comptroller for
7 funding the unfunded liabilities of the Teachers' Retirement
8 System of the State of Illinois. Amounts appropriated under
9 this Section shall be in addition to, and not in lieu of, any
10 State contributions required under Section 16-158 of the
11 Illinois Pension Code.

12 (P.A. 102-0017, Article 35, Section 105, new)

13 Sec. 105. The amount of \$58,138,900, or so much thereof
14 as may be necessary, is appropriated from the Pension
15 Stabilization Fund to the Office of the State Comptroller for
16 funding the unfunded liabilities of the State Universities
17 Retirement System. Amounts appropriated under this Section
18 shall be in addition to, and not in lieu of, any State
19 contributions required under Section 15-155 of the Illinois
20 Pension Code.

21 ARTICLE 2

1 Section 1. "AN ACT concerning appropriations", Public Act
2 102-0017, certified June 17, 2021, is amended by changing
3 Section 5 of Article 44 as follows:

4 (P.A. 102-0017, Article 44, Section 5)

5 Sec. 5. The sum of \$2,749,744,600 ~~1,851,475,900~~, or so much
6 thereof as may be necessary, is appropriated from the General
7 Revenue Fund to the Department of Central Management Services
8 for Group Insurance.

9 ARTICLE 3

10 Section 1. "AN ACT concerning appropriations", Public Act
11 102-0017, certified June 17, 2021, is amended by adding section
12 35 to Article 53 as follows:

13 (P.A. 102-0017, Article 53, Section 35, new)

14 Sec. 35. The sum of \$2,000,000,000, or so much thereof as
15 may be necessary, is appropriated from the State Coronavirus
16 Urgent Remediation Emergency Fund to the Department of
17 Employment Security for payment to the Illinois Unemployment
18 Insurance Trust Fund for partial repayment of Title XII
19 advances, including prior year costs.

20 ARTICLE 4

1 Section 1. "AN ACT concerning appropriations", Public Act
2 102-0017, certified June 17, 2021, is amended by changing
3 Section 135 of Article 122 as follows:

4 (P.A. 102-0017, Article 122, Section 135)

5 Sec. 135. The sum of \$250,000,000 ~~20,000,000~~, or so much
6 thereof as may be necessary, is appropriated from the General
7 Revenue Fund to the Illinois Student Assistance Commission for
8 deposit into the Illinois Prepaid Tuition Trust Fund.

9 Section 99. Effective date. This Act takes effect
10 Immediately."
