Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Article 1.

5 Section 1-5. The Director of Corrections, on behalf of the 6 State of Illinois, is authorized to execute and deliver to the 7 Village of Hopkins Park, organized and existing under the laws 8 of the State of Illinois, of Kankakee County, State of 9 Illinois, for and in consideration of \$1 paid to the 10 Department of Corrections, a quitclaim deed to the following 11 real property:

utilities, existing public roads, 1 and any and all 2 reservations, easements, encumbrances, covenants, and 3 restrictions of record; and (2) the express condition that if the real property ceases to be used for public purposes, it 4 shall revert to the State of Illinois, Department of 5 6 Corrections.

Section 1-15. The Director of Corrections shall obtain a certified copy of this Act within 60 days after its effective date and, upon receipt of the payment required by Section 1-5, shall record the certified document in the Recorder's Office in the County in which the land is located.

Subject to the conditions set forth in 14 Section 2-10, the Director of the Department of Corrections, 15 on behalf of the State of Illinois, shall execute and deliver 16 to the Lockport Township Fire Protection District, for and in 17 consideration of \$1 paid to the Department, a quitclaim deed 18 for the following described real property:

2-5 shall be made subject to existing public utilities,
existing public roads, and any and all reservations,
easements, encumbrances, covenants, and restrictions of
record.

Protection District shall state on its face and be subject to 1 2 the conditions that the real property shall be used by the 3 Lockport Township Fire Protection District for a training center and that if the Lockport Township Fire Protection 4 5 District ceases to exist, if the real property is used for any purposes other than a training center, or if an attempt is made 6 to sell the property, then title shall revert without further 7 action to the State of Illinois. 8

Director of 9 Section 2-15. The the Department of 10 Corrections shall prepare one or more quitclaim deeds to 11 convey the real property. The Director may also record a 12 certified copy of this Act. Each quitclaim deed shall 13 reference this Act and contain the reversionary language from subsection (c) of Section 2-10. All documents of conveyance 14 15 shall be recorded in the county in which the land is located.
