SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.970 new 30 ILCS 105/6z-130 new

Amends the State Finance Act. Creates the Growing Manufacturing Jobs Fund as a special fund in the State treasury. Provides that moneys in the Fund shall be administered by the Department of Commerce and Economic Opportunity, in consultation with a statewide manufacturing association, for the purpose of establishing and operating a statewide marketing campaign to increase the number of people entering high-demand manufacturing occupations. Provides findings provisions. Makes conforming changes.

1 AN ACT concerning finance.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 1. Findings. The General Assembly finds and declares the following:

The Illinois manufacturing sector is critical to the success of our State and nation. Recent events, including the global pandemic, supply chain shortages, and lack of workforce have led to struggles in the manufacturing sector.

Illinois manufacturers employ 554,000 women and men on factory floors today in jobs that average nearly \$88,000 in wages and benefits with 92% of employees receiving employer-funded health care. Manufacturers provide the single largest share of Illinois' gross State product, but are challenged to find skilled workers.

National labor data shows that the United States now has more than 1,000,000 open manufacturing jobs, which is the highest recorded level in history and more than double the unfilled jobs in February 2020. It is imperative that Illinois work with the statewide manufacturing associations, colleges and universities, K-12 school districts, economic development officials, and individual companies to attract and recruit workers into the manufacturing sector.

The State of Illinois' 5-year economic plan calls for a
