SYNOPSIS AS INTRODUCED:

105 ILCS 5/21B-15 105 ILCS 5/21B-20

Amends the Educator Licensure Article of the School Code. Provides that a paraprofessional educator endorsement on an Educator License with Stipulations may be issued to an applicant who is at least 18 years of age and will be using the Educator License with Stipulations exclusively for elementary education. Makes a corresponding change.

AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Sections
21B-15 and 21B-20 as follows:

6 (105 ILCS 5/21B-15)

7 Sec. 21B-15. Qualifications of educators.

8 (a) No one may be licensed to teach or supervise or be 9 otherwise employed in the public schools of this State who is 10 not of good character and at least 19 years of age, except as 11 <u>otherwise provided in subparagraph (J) of subsection (2) of</u> 12 Section 21B-20.

In determining good character under this Section, the 13 14 State Superintendent of Education shall take into consideration the disciplinary actions of other states or 15 national entities against certificates or licenses issued by 16 17 those states and held by individuals from those states. In addition, any felony conviction of the applicant may be taken 18 19 into consideration; however, no one may be licensed to teach 20 or supervise in the public schools of this State who has been 21 convicted of (i) an offense set forth in subsection (b) of Section 21B-80 of this Code until 7 years following the end of 22 the sentence for the criminal offense or (ii) an offense set 23

forth in subsection (c) of Section 21B-80 of this Code. Unless the conviction is for an offense set forth in Section 21B-80 of this Code, an applicant must be permitted to submit character references or other written material before such a conviction or other information regarding the applicant's character may be used by the State Superintendent of Education as a basis for denying the application.

8 (b) No person otherwise qualified shall be denied the 9 right to be licensed or to receive training for the purpose of 10 becoming an educator because of a physical disability, 11 including, but not limited to, visual and hearing 12 disabilities; nor shall any school district refuse to employ a teacher on such grounds, provided that the person is able to 13 carry out the duties of the position for which he or she 14 applies. 15

16 (c) No person may be granted or continue to hold an 17 educator license who has knowingly altered or misrepresented his or her qualifications, in this State or any other state, in 18 19 order to acquire or renew the license. Any other license 20 issued under this Article held by the person may be suspended or revoked by the State Educator Preparation and Licensure 21 22 Board, depending upon the severity of the alteration or 23 misrepresentation.

(d) No one may teach or supervise in the public schools nor
receive for teaching or supervising any part of any public
school fund who does not hold an educator license granted by

1 the State Superintendent of Education as provided in this 2 Article. However, the provisions of this Article do not apply 3 to a member of the armed forces who is employed as a teacher of 4 subjects in the Reserve Officers' Training Corps of any 5 school, nor to an individual teaching a dual credit course as 6 provided for in the Dual Credit Quality Act.

7 (e) Notwithstanding any other provision of this Code, the 8 school board of a school district may grant to a teacher of the 9 district a leave of absence with full pay for a period of not 10 more than one year to permit the teacher to teach in a foreign 11 state under the provisions of the Exchange Teacher Program 12 established under Public Law 584, 79th Congress, and Public Law 402, 80th Congress, as amended. The school board granting 13 14 the leave of absence may employ, with or without pay, a 15 national of the foreign state wherein the teacher on the leave 16 of absence is to teach if the national is qualified to teach in 17 that foreign state and if that national is to teach in a grade level similar to the one that was taught in the foreign state. 18 19 The State Board of Education, in consultation with the State 20 Educator Preparation and Licensure Board, may adopt rules as 21 may be necessary to implement this subsection (e).

(f) No person shall be denied a license issued under this Article solely based on his or her citizenship status or immigration status. The General Assembly finds and declares that this subsection (f) is a State law within the meaning of subsection (d) of Section 1621 of Title 8 of the United States

1 Code. Nothing in this subsection shall affect the requirements 2 to obtain a license that are not directly related to 3 citizenship status or immigration status. Nothing in this 4 subsection shall be construed to grant eligibility for 5 obtaining any public benefit other than a license issued under 6 this Article.

10 Sec. 21B-20. Types of licenses. The State Board of 11 Education shall implement a system of educator licensure, 12 whereby individuals employed in school districts who are required to be licensed must have one of the following 13 14 licenses: (i) a professional educator license; (ii) an 15 educator license with stipulations; (iii) a substitute 16 teaching license; or (iv) until June 30, 2023, a short-term substitute teaching license. References in law regarding 17 individuals certified or certificated or required to be 18 19 certified or certificated under Article 21 of this Code shall 20 also include individuals licensed or required to be licensed 21 under this Article. The first year of all licenses ends on June 22 30 following one full year of the license being issued.

The State Board of Education, in consultation with the State Educator Preparation and Licensure Board, may adopt such rules as may be necessary to govern the requirements for - 5 - LRB102 24650 NLB 33889 b

licenses and endorsements under this Section.

2 (1) Professional Educator License. Persons who (i) 3 have successfully completed an approved educator preparation program and are recommended for licensure by 4 5 the Illinois institution offering the educator preparation program, (ii) have successfully completed the required 6 7 testing under Section 21B-30 of this Code, (iii) have 8 successfully completed coursework on the psychology of, 9 the identification of, and the methods of instruction for 10 the exceptional child, including without limitation 11 children with learning disabilities, (iv) have 12 successfully completed coursework in methods of reading and reading in the content area, and (v) have met all other 13 14 criteria established by rule of the State Board of 15 Education shall be issued a Professional Educator License. 16 All Professional Educator Licenses are valid until June 30 17 immediately following 5 years of the license being issued. The Professional Educator License shall be endorsed with 18 specific areas and grade levels in which the individual is 19 20 eligible to practice. For an early childhood education 21 endorsement, an individual may satisfy the student 22 teaching requirement of his or her early childhood teacher 23 preparation program through placement in a setting with 24 children from birth through grade 2, and the individual 25 may be paid and receive credit while student teaching. The 26 student teaching experience must meet the requirements of

1 2 and be approved by the individual's early childhood teacher preparation program.

Individuals can receive subsequent endorsements on the Professional Educator License. Subsequent endorsements shall require a minimum of 24 semester hours of coursework in the endorsement area and passage of the applicable content area test, unless otherwise specified by rule.

8 (2) Educator License with Stipulations. An Educator 9 License with Stipulations shall be issued an endorsement 10 that limits the license holder to one particular position 11 or does not require completion of an approved educator 12 program or both.

An individual with an Educator License with Stipulations must not be employed by a school district or any other entity to replace any presently employed teacher who otherwise would not be replaced for any reason.

An Educator License with Stipulations may be issuedwith the following endorsements:

(A) (Blank).

(B) Alternative provisional educator. An
alternative provisional educator endorsement on an
Educator License with Stipulations may be issued to an
applicant who, at the time of applying for the
endorsement, has done all of the following:

(i) Graduated from a regionally accreditedcollege or university with a minimum of a

bachelor's degree.

(ii) Successfully completed the first phase of the Alternative Educator Licensure Program for Teachers, as described in Section 21B-50 of this Code.

(iii) Passed a content area test, as required under Section 21B-30 of this Code.

8 The alternative provisional educator endorsement is 9 valid for 2 years of teaching and may be renewed for a 10 third year by an individual meeting the requirements set 11 forth in Section 21B-50 of this Code.

12 (C) Alternative provisional superintendent. An 13 alternative provisional superintendent endorsement on 14 an Educator License with Stipulations entitles the 15 holder to serve only as a superintendent or assistant 16 superintendent in a school district's central office. 17 This endorsement may only be issued to an applicant who, at the time of applying for the endorsement, has 18 done all of the following: 19

(i) Graduated from a regionally accredited
college or university with a minimum of a master's
degree in a management field other than education.

(ii) Been employed for a period of at least 5
years in a management level position in a field
other than education.

(iii) Successfully completed the first phase

of an alternative route to superintendent endorsement program, as provided in Section 21B-55 of this Code.

4 (iv) Passed a content area test required under 5 Section 21B-30 of this Code.

The endorsement is valid for 2 fiscal years in order to complete one full year of serving as a superintendent or assistant superintendent.

(D) (Blank).

(E) Career and technical educator. A career and 10 11 technical educator endorsement on an Educator License 12 with Stipulations may be issued to an applicant who 13 has a minimum of 60 semester hours of coursework from a regionally accredited institution of higher education 14 15 or an accredited trade and technical institution and 16 has a minimum of 2,000 hours of experience outside of 17 education in each area to be taught.

18The career and technical educator endorsement on19an Educator License with Stipulations is valid until20June 30 immediately following 5 years of the21endorsement being issued and may be renewed.

An individual who holds a valid career and technical educator endorsement on an Educator License with Stipulations but does not hold a bachelor's degree may substitute teach in career and technical education classrooms.

(F) Part-time provisional career and technical 1 educator or provisional career and technical educator. 2 A part-time provisional career and technical educator 3 endorsement or a provisional career and technical 4 5 educator endorsement on an Educator License with 6 Stipulations may be issued to an applicant who has a 7 minimum of 8,000 hours of work experience in the skill for which the applicant is seeking the endorsement. It 8 9 is the responsibility of each employing school board 10 and regional office of education to provide 11 verification, in writing, to the State Superintendent 12 of Education at the time the application is submitted 13 that no qualified teacher holding a Professional with 14 Educator License or an Educator License 15 Stipulations with a career and technical educator 16 endorsement is available and that actual circumstances 17 require such issuance.

18The provisional career and technical educator19endorsement on an Educator License with Stipulations20is valid until June 30 immediately following 5 years21of the endorsement being issued and may be renewed for225 years.

A part-time provisional career and technical educator endorsement on an Educator License with Stipulations may be issued for teaching no more than 2 courses of study for grades 6 through 12. The

part-time provisional career and technical educator endorsement on an Educator License with Stipulations is valid until June 30 immediately following 5 years of the endorsement being issued and may be renewed for 5 years if the individual makes application for renewal.

An individual who holds a provisional or part-time provisional career and technical educator endorsement on an Educator License with Stipulations but does not hold a bachelor's degree may substitute teach in career and technical education classrooms.

12 (G) Transitional bilingual educator. Α 13 transitional bilingual educator endorsement on an 14 Educator License with Stipulations may be issued for 15 the purpose of providing instruction in accordance 16 with Article 14C of this Code to an applicant who 17 provides satisfactory evidence that he or she meets all of the following requirements: 18

19 (i) Possesses adequate speaking, reading, and
20 writing ability in the language other than English
21 in which transitional bilingual education is
22 offered.

(ii) Has the ability to successfullycommunicate in English.

25 (iii) Either possessed, within 5 years
 26 previous to his or her applying for a transitional

1 bilingual educator endorsement, a valid and 2 comparable teaching certificate or comparable 3 authorization issued by a foreign country or holds a degree from an institution of higher learning in 4 5 foreign country that the State Educator а 6 Preparation and Licensure Board determines to be 7 the equivalent of a bachelor's degree from a 8 regionally accredited institution of higher 9 learning in the United States.

10 A transitional bilingual educator endorsement 11 shall be valid for prekindergarten through grade 12, 12 is valid until June 30 immediately following 5 years 13 of the endorsement being issued, and shall not be 14 renewed.

Persons holding a transitional bilingual educator endorsement shall not be employed to replace any presently employed teacher who otherwise would not be replaced for any reason.

19 Language endorsement. Τn an effort. (H) to 20 alleviate the shortage of teachers speaking a language 21 other than English in the public schools, an 22 individual who holds an Educator License with 23 Stipulations may also apply for а language 24 endorsement, provided that the applicant provides 25 satisfactory evidence that he or she meets all of the 26 following requirements:

1 (i) Holds a transitional bilingual 2 endorsement.

> (ii) Has demonstrated proficiency in the language for which the endorsement is to be issued by passing the applicable language content test required by the State Board of Education.

7 (iii) Holds a bachelor's degree or higher from 8 a regionally accredited institution of higher 9 education or, for individuals educated in a 10 country other than the United States, holds a 11 degree from an institution of higher learning in a 12 foreign country that the State Educator 13 Preparation and Licensure Board determines to be 14 the equivalent of a bachelor's degree from a 15 regionally accredited institution of higher 16 learning in the United States.

(iv) (Blank).

A language endorsement on an Educator License with 18 19 Stipulations is valid for prekindergarten through 20 grade 12 for the same validity period as the 21 individual's transitional bilingual educator 22 endorsement on the Educator License with Stipulations 23 and shall not be renewed.

(I) Visiting international educator. A visiting
 international educator endorsement on an Educator
 License with Stipulations may be issued to an

individual who is being recruited by a particular school district that conducts formal recruitment programs outside of the United States to secure the services of qualified teachers and who meets all of the following requirements:

(i) Holds the equivalent of a minimum of a bachelor's degree issued in the United States.

(ii) Has been prepared as a teacher at the grade level for which he or she will be employed.

10 (iii) Has adequate content knowledge in the11 subject to be taught.

12 (iv) Has an adequate command of the English13 language.

A holder of a visiting international educator 14 15 endorsement on an Educator License with Stipulations 16 shall be permitted to teach in bilingual education 17 programs in the language that was the medium of instruction in his or her teacher preparation program, 18 19 provided that he or she passes the English Language Proficiency Examination or another test of writing 20 21 skills in English identified by the State Board of 22 Education, in consultation with the State Educator 23 Preparation and Licensure Board.

A visiting international educator endorsement on an Educator License with Stipulations is valid for 5 years and shall not be renewed.

(J) Paraprofessional educator. A paraprofessional 1 2 educator endorsement on an Educator License with 3 Stipulations may be issued to an applicant who holds a high school diploma or its recognized equivalent and 4 5 (i) either holds an associate's degree or a minimum of semester hours of credit from a regionally 6 60 7 accredited institution of higher education; (ii) or has passed a paraprofessional competency test under 8 9 subsection (c-5) of Section 21B-30; or (iii) is at 10 least 18 years of age and will be using the Educator 11 License with Stipulations exclusively for elementary 12 education. The paraprofessional educator endorsement 13 is valid until June 30 immediately following 5 years 14 of the endorsement being issued and may be renewed 15 through application and payment of the appropriate 16 fee, as required under Section 21B-40 of this Code. An 17 individual who holds only a paraprofessional educator endorsement is not subject to additional requirements 18 in order to renew the endorsement. 19

(K) Chief school business official. A chief school
business official endorsement on an Educator License
with Stipulations may be issued to an applicant who
qualifies by having a master's degree or higher, 2
years of full-time administrative experience in school
business management or 2 years of university-approved
practical experience, and a minimum of 24 semester

hours of graduate credit in a program approved by the State Board of Education for the preparation of school business administrators and by passage of the applicable State tests, including an applicable content area test.

6 The chief school business official endorsement may 7 also be affixed to the Educator License with Stipulations of any holder who qualifies by having a 8 9 master's degree in business administration, finance, 10 accounting, or public administration and who completes 11 an additional 6 semester hours of internship in school 12 business management from a regionally accredited 13 institution of higher education and passes the 14 applicable State tests, including an applicable 15 content area test. This endorsement shall be required 16 for any individual employed as a chief school business 17 official.

The chief school business official endorsement on 18 19 an Educator License with Stipulations is valid until immediately following 5 20 June 30 years of the endorsement being issued and may be renewed if the 21 22 license holder completes renewal requirements as 23 required for individuals who hold a Professional Educator License endorsed for chief school business 24 25 official under Section 21B-45 of this Code and such 26 rules as may be adopted by the State Board of

1 Education.

The State Board of Education shall adopt any rules necessary to implement Public Act 100-288.

(L) Provisional in-state educator. A provisional 4 5 in-state educator endorsement on an Educator License with Stipulations may be issued to a candidate who has 6 7 completed an Illinois-approved educator preparation program at an Illinois institution of higher education 8 9 who successfully completed and has not an 10 evidence-based assessment of teacher effectiveness but 11 who meets all of the following requirements:

(i) Holds at least a bachelor's degree.

(ii) Has completed an approved educator
 preparation program at an Illinois institution.

(iii) Has passed an applicable content area
 test, as required by Section 21B-30 of this Code.

17 evidence-based (iv) Has attempted an assessment of teacher effectiveness and received a 18 19 minimum score on that assessment, as established 20 by the State Board of Education in consultation 21 with the State Educator Preparation and Licensure 22 Board.

A provisional in-state educator endorsement on an Educator License with Stipulations is valid for one full fiscal year after the date of issuance and may not be renewed.

(M) (Blank).

(N) Specialized services. A specialized services endorsement on an Educator License with Stipulations may be issued as defined and specified by rule.

5 (3) Substitute Teaching License. A Substitute Teaching 6 License may be issued to qualified applicants for 7 substitute teaching in all grades of the public schools, 8 prekindergarten through grade 12. Substitute Teaching 9 Licenses are not eligible for endorsements. Applicants for 10 a Substitute Teaching License must hold a bachelor's 11 degree or higher from a regionally accredited institution 12 of higher education.

13 Substitute Teaching Licenses are valid for 5 years.

14 Substitute Teaching Licenses are valid for substitute 15 teaching in every county of this State. If an individual 16 has had his or her Professional Educator License or 17 Educator License with Stipulations suspended or revoked, 18 then that individual is not eligible to obtain a 19 Substitute Teaching License.

20 A substitute teacher may only teach in the place of a 21 licensed teacher who is under contract with the employing board. If, however, there is no licensed teacher under 22 23 emergency situation, then contract because of an а 24 district may employ a substitute teacher for no longer 25 than 30 calendar days per each vacant position in the 26 district if the district notifies the appropriate regional

1 office of education within 5 business days after the 2 employment of the substitute teacher in the emergency 3 situation. An emergency situation is one in which an unforeseen vacancy has occurred and (i) a teacher is 4 5 unable to fulfill his or her contractual duties or (ii) teacher capacity needs of the district exceed previous 6 7 indications, and the district is actively engaged in 8 advertising to hire a fully licensed teacher for the 9 vacant position.

10 There is no limit on the number of days that a 11 substitute teacher may teach in a single school district, 12 provided that no substitute teacher may teach for longer than 90 school days for any one licensed teacher under 13 14 contract in the same school year. A substitute teacher who 15 holds a Professional Educator License or Educator License 16 with Stipulations shall not teach for more than 120 school 17 days for any one licensed teacher under contract in the 18 same school year. The limitations in this paragraph (3) on 19 the number of days a substitute teacher may be employed do 20 not apply to any school district operating under Article 34 of this Code. 21

A school district may not require an individual who holds a valid Professional Educator License or Educator License with Stipulations to seek or hold a Substitute Teaching License to teach as a substitute teacher.

(4) Short-Term Substitute Teaching License. Beginning

on July 1, 2018 and until June 30, 2023, the State Board of 1 2 Education may issue a Short-Term Substitute Teaching 3 License. A Short-Term Substitute Teaching License may be issued to a qualified applicant for substitute teaching in 4 5 all grades of the public schools, prekindergarten through 6 grade 12. Short-Term Substitute Teaching Licenses are not 7 eligible for endorsements. Applicants for a Short-Term 8 Substitute Teaching License must hold an associate's 9 degree or have completed at least 60 credit hours from a 10 regionally accredited institution of higher education.

11 Short-Term Substitute Teaching Licenses are valid for 12 substitute teaching in every county of this State. If an 13 individual has had his or her Professional Educator 14 License or Educator License with Stipulations suspended or 15 revoked, then that individual is not eligible to obtain a 16 Short-Term Substitute Teaching License.

17The provisions of Sections 10-21.9 and 34-18.5 of this18Code apply to short-term substitute teachers.

19 An individual holding a Short-Term Substitute Teaching 20 License may teach no more than 5 consecutive days per licensed teacher who is under contract. For teacher 21 22 absences lasting 6 or more days per licensed teacher who 23 is under contract, a school district may not hire an 24 individual holding a Short-Term Substitute Teaching 25 License. An individual holding a Short-Term Substitute 26 Teaching License must complete the training program under Section 10-20.67 or 34-18.60 of this Code to be eligible
to teach at a public school. This paragraph (4) is
inoperative on and after July 1, 2023.
