#### SB3989

## SYNOPSIS AS INTRODUCED:

305 ILCS 5/12-4.35

Amends the Illinois Public Aid Code. Provides that by January 1, 2023, the Department of Healthcare and Family Services may provide medical services to noncitizens aged 19 or older, but younger than 55, who (i) are not eligible for medical assistance under Article V of the Code due to their not meeting the otherwise applicable provisions of the Code concerning citizenship and (ii) have income at or below 133% of the federal poverty level plus 5% for the applicable family size as determined under applicable federal law and regulations. Provides that persons eligible for medical services under the amendatory Act shall receive benefits identical to the benefits provided under the Health Benefits Service Package as that term is defined in the Code. Effective immediately.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Public Aid Code is amended by 5 changing Section 12-4.35 as follows:

Sec. 12-4.35. Medical services for certain noncitizens.

(a) Notwithstanding Section 1-11 of this Code or Section 8 9 20(a) of the Children's Health Insurance Program Act, the Department of Healthcare and Family Services may provide 10 medical services to noncitizens who have not yet attained 19 11 years of age and who are not eligible for medical assistance 12 under Article V of this Code or under the Children's Health 13 14 Insurance Program created by the Children's Health Insurance Program Act due to their not meeting the otherwise applicable 15 16 provisions of Section 1-11 of this Code or Section 20(a) of the 17 Children's Health Insurance Program Act. The medical services available, standards for eligibility, and other conditions of 18 19 participation under this Section shall be established by rule by the Department; however, any such rule shall be at least as 20 21 restrictive as the rules for medical assistance under Article 22 V of this Code or the Children's Health Insurance Program created by the Children's Health Insurance Program Act. 23

(a-5) Notwithstanding Section 1-11 of this Code, the 1 2 Department of Healthcare and Family Services may provide medical assistance in accordance with Article V of this Code 3 to noncitizens over the age of 65 years of age who are not 4 5 eligible for medical assistance under Article V of this Code due to their not meeting the otherwise applicable provisions 6 of Section 1-11 of this Code, whose income is at or below 100% 7 of the federal poverty level after deducting the costs of 8 9 medical or other remedial care, and who would otherwise meet the eligibility requirements in Section 5-2 of this Code. The 10 11 medical services available, standards for eligibility, and 12 other conditions of participation under this Section shall be established by rule by the Department; however, any such rule 13 shall be at least as restrictive as the rules for medical 14 assistance under Article V of this Code. 15

16 (a-6) By May 30, 2022, notwithstanding Section 1-11 of 17 this Code, the Department of Healthcare and Family Services may provide medical services to noncitizens 55 years of age 18 through 64 years of age who (i) are not eligible for medical 19 assistance under Article V of this Code due to their not 20 meeting the otherwise applicable provisions of Section 1-11 of 21 22 this Code and (ii) have income at or below 133% of the federal 23 poverty level plus 5% for the applicable family size as 24 determined under applicable federal law and regulations. 25 Persons eligible for medical services under Public Act 102-16 26 this amendatory Act of the 102nd General Assembly shall

receive benefits identical to the benefits provided under the
 Health Benefits Service Package as that term is defined in
 subsection (m) of Section 5-1.1 of this Code.

(a-7) By January 1, 2023, notwithstanding Section 1-11 of 4 5 this Code, the Department of Healthcare and Family Services may provide medical services to noncitizens aged 19 or older, 6 but younger than 55, who (i) are not eligible for medical 7 assistance under Article V of this Code due to their not 8 9 meeting the otherwise applicable provisions of Section 1-11 of 10 this Code and (ii) have income at or below 133% of the federal 11 poverty level plus 5% for the applicable family size as 12 determined under applicable federal law and regulations. 13 Persons eligible for medical services under this amendatory 14 Act of the 102nd General Assembly shall receive benefits identical to the benefits provided under the Health Benefits 15 16 Service Package as that term is defined in subsection (m) of 17 Section 5-1.1 of this Code.

18 (a-10) Notwithstanding the provisions of Section 1-11, the 19 Department shall cover immunosuppressive drugs and related 20 services associated with post-kidney transplant management, 21 excluding long-term care costs, for noncitizens who: (i) are 22 not eligible for comprehensive medical benefits; (ii) meet the 23 residency requirements of Section 5-3; and (iii) would meet 24 the financial eligibility requirements of Section 5-2.

(b) The Department is authorized to take any action that would not otherwise be prohibited by applicable law,

including, without limitation, cessation or limitation of enrollment, reduction of available medical services, and changing standards for eligibility, that is deemed necessary by the Department during a State fiscal year to assure that payments under this Section do not exceed available funds.
