Be it enacted by the People of the State of Illinois, represented 2 in the General Assembly: 3

Section 5. The sum of \$623,324,500, or so much thereof as 4 may be necessary, is appropriated from the Education Assistance 5 Fund to the Board of Trustees of the University of Illinois to 6 meet its operational expenses for the fiscal year ending June 7 8 30, 2023.

9	Section 10. The following named amounts, or so much thereof
10	as may be necessary, are appropriated from the Education
11	Assistance Fund to the Board of Trustees of the University of

Section 15. The sum of \$15,091,800, or so much thereof as 16 17 may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for 18 costs and expenses related to or in support of the Prairie 19 20 Research Institute, in accordance with Public Act 95-0728.

Section 20. The sum of \$40,380,600, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for operating costs and expenses related to or in support of the University of Illinois Hospital.

The sum of \$5,127,300, or so much thereof as may be necessary, is appropriated from the Fire Prevention Fund to the Board of Trustees of the University of Illinois for the purpose of maintaining the Illinois Fire Service Institute, paying the Institute's expenses, and providing the facilities and structures incident thereto, including payment to the University for personal services and related costs incurred.

5 Section 70. The sum of \$400,000, or so much thereof as may 6 be necessary, is appropriated from the Used Tire Management 7 Fund to the University of Illinois for costs and expenses 8 related to or in support of mosquito research and abatement.

9 Section 75. The sum of \$500,000, or so much thereof as may 10 be necessary, is appropriated from the Hazardous Waste Research 11 Fund to the University of Illinois for its ordinary and 12 contingent expenses.

13 Section 80. The sum of \$500,000, or so much thereof as may 14 be necessary, is appropriated from the General Professions 15 Dedicated Fund to the Board of Trustees of the University of 16 Illinois for costs associated with the development, support, 17 or administration of pharmacy practice education or training 18 programs for the College of Medicine at Rockford.

Section 85. The sum of \$8,000,000, or so much thereof asmay be necessary and remains unexpended at the close of business

1 on June 30, 2022 from an appropriation heretofore made for that 2 purpose in Section 85 of Article 120 of Public Act 102-17, is 3 reappropriated from the Coal Technology Development Assistance 4 Fund to the University of Illinois for the Prairie Research 5 Institute for costs associated with carbon dioxide capture 6 technology at a coal-fired power plant, and other projects in 7 consultation with the United States Department of Energy.

8 Section 90. The sum of \$175,000, or so much thereof as may 9 be necessary and remains unexpended at the close of business 10 on June 30, 2022 from an appropriation heretofore made for that purpose in Section 90 of Article 120 of Public Act 102-17, is 11 12 reappropriated from the Coal Technology Development Assistance 13 Fund to the University of Illinois for the Prairie Research Institute for costs associated with conducting the carbon 14 15 capture, utilization, and storage study.

16 Section 95. The sum of \$769,000, or so much thereof as may 17 be necessary and remains unexpended at the close of business 18 on June 30, 2022, from an appropriation heretofore made for that purpose in Section 215 of Article 127 of Public Act 102-19 20 17, is reappropriated from the State Coronavirus Urgent 21 Remediation Emergency Fund to the Board of Trustees of the 22 University of Illinois for costs associated with the water rates report under Section 115 of the University of Illinois 23
