A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$6,000,000, or so much thereof as
6 may be necessary, is appropriated to the Illinois Student
7 Assistance Commission from the General Revenue Fund to meet its
8 operational expenses for the fiscal year ending June 30, 2023.

9 Section 10. The following named amount, or so much thereof
10 as may be necessary, is appropriated from the General Revenue
11 Fund to the Illinois Student Assistance Commission for the
12 following purpose:

13 To support outreach, research, and
14 training activities6,000,000

15 Section 15. The sum of \$301,566,200, or so much thereof
16 as may be necessary, is appropriated to the Illinois Student
17 Assistance Commission from the General Revenue Fund for grant
18 awards to students eligible for the Monetary Award Program, as
19 provided by law, and for agency administrative and operational
20 costs not to exceed 2 percent of the total appropriation in

1 this Section.

2 Section 20. The sum of \$300,000,000, or so much thereof
3 as may be necessary, is appropriated to the Illinois Student
4 Assistance Commission from the Education Assistance Fund for
5 grant awards to students eligible for the Monetary Award
6 Program, as provided by law, and for agency administrative and
7 operational costs not to exceed 2 percent of the total
8 appropriation in this Section.

9 Section 25. The sum of \$35,000,000, or so much thereof as
10 may be necessary, is appropriated to the Illinois Student
11 Assistance Commission from the General Revenue Fund for
12 payments to eligible public universities for grants to students
13 pursuant to the AIM HIGH program.

14 Section 30. The sum of \$150,000, or so much thereof as may
15 be necessary, is appropriated from the General Revenue Fund to
16 the Illinois Student Assistance Commission for costs associated
17 with providing grants to exonerated persons, as provided by
18 law.

19 Section 35. The sum of \$26,400, or so much thereof as may
20 be necessary, is appropriated from the Education Assistance
21 Fund to the Illinois Student Assistance Commission for costs

1 associated with the Veterans' Home Medical Providers' Loan
2 Repayment Program pursuant to Public Act 99-0813.

3 Section 40. The sum of \$500,000, or so much thereof as may
4 be necessary, is appropriated from the Education Assistance
5 Fund to the Illinois Student Assistance Commission for grants
6 to eligible nurse educators to use for payment of their
7 educational loan pursuant to Public Act 94-1020.

8 Section 45. The following named sums, or so much thereof
9 as may be necessary, respectively, are appropriated from the
10 Education Assistance Fund to the Illinois Student Assistance
11 Commission for the following purposes:

12 Grants and Scholarships

13	For the payment of scholarships to students	
14	who are children of police officers or firefighters	
15	killed in the line of duty, or who are	
16	dependents of correctional officers killed	
17	or permanently disabled in the line of	
18	duty, as provided by law	1,273,300
19	For payment of Minority Teacher Scholarships	<u>4,200,000</u>
20	Total	\$5,473,300

21 Section 50. The sum of \$6,498,000, or so much thereof as
22 may be necessary, is appropriated from the Education Assistance

1 Fund to the Illinois Student Assistance Commission to the
2 Golden Apple Scholars of Illinois program, as provided by law.

3 Section 55. The sum of \$750,000, or so much thereof as may
4 be necessary, is appropriated from the Education Assistance
5 Fund to the Illinois Student Assistance Commission to the
6 Golden Apple Scholars of Illinois program for the Golden Apple
7 Accelerators Program.

8 Section 60. The sum of \$439,900, or so much thereof as may
9 be necessary, is appropriated from the Education Assistance
10 Fund to the Illinois Student Assistance Commission for the Loan
11 Repayment for Teachers Program.

12 Section 65. The sum of \$300,000, or so much thereof as may
13 be necessary, is appropriated from the ISAC Accounts Receivable
14 Fund to the Illinois Student Assistance Commission for costs
15 associated with the collection of delinquent scholarship awards
16 pursuant to the Illinois State Collection Act of 1986.

17 Section 70. The sum of \$110,000, or so much thereof as may
18 be necessary, is appropriated to the Illinois Student
19 Assistance Commission from the University Grant Fund for
20 payment of grants for the Higher Education License Plate
21 Program, as provided by law.

1 Section 75. The following named sum, or so much thereof
 2 as may be necessary, is appropriated from the Illinois Student
 3 Assistance Commission Contracts and Grants Fund to the Illinois
 4 Student Assistance Commission for the following purpose:

5 To support outreach, research, and
 6 training activities5,000,000
 7 Community Behavioral Health Care
 8 Provider Loan Repayment Program5,000,000

9 Section 80. The following named sum, or so much thereof
 10 as may be necessary, is appropriated from the Optometric
 11 Licensing and Disciplinary Board Fund to the Illinois Student
 12 Assistance Commission for the following purpose:

13 Grants and Scholarships
 14 For payment of scholarships for the
 15 Optometric Education Scholarship
 16 Program, as provided by law50,000

17 Section 85. The following named sum, or so much thereof
 18 as may be necessary, is appropriated from the National Guard
 19 and Naval Militia Grant Fund to the Illinois Student Assistance
 20 Commission for the following purpose:

21 Grants and Scholarships
 22 For payment of Illinois National Guard and

1 Naval Militia Scholarships
 2 at State-controlled universities
 3 and public community colleges in
 4 Illinois to students eligible to
 5 receive such awards, as provided by law20,000

6 Section 90. The sum of \$100,000, or so much thereof as may
 7 be necessary, is appropriated from the Golden Apple Scholars
 8 of Illinois Fund to the Illinois Student Assistance Commission
 9 for the Golden Apple Scholars of Illinois Program, as provided
 10 by law.

11 Section 95. The following named sums, or so much thereof
 12 as may be necessary, respectively, are appropriated to the
 13 Illinois Student Assistance Commission from the Student Loan
 14 Operating Fund for its ordinary and contingent expenses:

8 Section 100. The sum of \$1,500,000, or so much thereof as
9 may be necessary, is appropriated to the Illinois Student
10 Assistance Commission from the Student Loan Operating Fund for
11 costs associated with Federal Loan System Development and
12 Maintenance.

13 Section 105. The sum of \$1,000,000 or so much thereof as
14 may be necessary, is appropriated to the Illinois Student
15 Assistance Commission from the Student Loan Operating Fund for
16 costs associated with the Illinois Designated Account Purchase
17 Program.

18 Section 110. The sum of \$2,000,000, or so much thereof as
19 may be necessary, is appropriated to the Illinois Student
20 Assistance Commission from the Student Loan Operating Fund for
21 distribution as necessary for the following: for payment of
22 collection agency fees associated with collection activities

1 for Federal Family Education Loans, for Default Aversion Fee
 2 reversals, and for distributions as necessary and provided for
 3 under the Federal Higher Education Act.

4 Section 115. The following named sum, or so much thereof
 5 as may be necessary, is appropriated from the Federal
 6 Congressional Teacher Scholarship Program Fund to the Illinois
 7 Student Assistance Commission for the following purpose:

8 For transferring repayment funds collected
 9 under the Paul Douglas Teacher Scholarship
 10 Program to the U.S. Treasury100,000

11 Section 120. The sum of \$100,000,000, or so much thereof
 12 as may be necessary, is appropriated from the Federal Student
 13 Loan Fund to the Illinois Student Assistance Commission for
 14 distribution when necessary as a result of the following: for
 15 guarantees of loans that are uncollectible, for collection
 16 payments to the Student Loan Operating Fund as required under
 17 agreements with the United States Secretary of Education, for
 18 payment to the Student Loan Operating Fund for Default Aversion
 19 Fees, for transfers to the U.S. Treasury, or for other
 20 distributions as necessary and provided for under the Federal
 21 Higher Education Act.

22 Section 125. The sum of \$13,000,000, or so much thereof

1 as may be necessary, is appropriated from the Federal Student
2 Incentive Trust Fund to the Illinois Student Assistance
3 Commission for allowable uses of federal grant funds related
4 to college access, outreach, and training, including but not
5 limited to funds received under the federal Gaining Early
6 Awareness and Readiness for Undergraduate Program.

7 Section 130. The sum of \$300,000, or so much thereof as
8 may be necessary, is appropriated from the Federal Student
9 Incentive Trust Fund to the Illinois Student Assistance
10 Commission for the John R. Justice Student Loan Repayment
11 Program.

12 Section 135. The sum of \$120,000,000, or so much thereof
13 as may be necessary, is appropriated from the Student Loan
14 Operating Fund to the Illinois Student Assistance Commission
15 for financial assistance and administrative costs associated
16 with early childhood programs.

17 Section 140. The sum of \$4,000,000, or so much thereof as
18 may be necessary, is appropriated from the Nursing Dedicated
19 and Professional Fund to the Illinois Student Assistance
20 Commission for expenses related to the Nursing Education
21 Scholarship Law.

1 Section 145. The sum of \$1,100,000, or so much thereof as
2 may be necessary, is appropriated from the Energy Transition
3 Assistance Fund to the Illinois Student Assistance Commission
4 for costs associated with providing grants to eligible
5 individuals, for costs pursuant to the Energy Transition Act.

6 ARTICLE 2

7 Section 5. The sum of \$3,502,000, or so much thereof as
8 may be necessary and remains unexpended at the close of business
9 on June 30, 2022, from an appropriation heretofore made for
10 such purpose in Article 127, Section 375 of Public Act 102-
11 0017, as amended, is reappropriated from the State Coronavirus
12 Urgent Remediation Emergency Fund to the Illinois Student
13 Assistance Commission for the Golden Apple Scholars of Illinois
14 Program, for purposes permitted by Section 9901 of the American
15 Rescue Plan Act of 2021 and related federal guidance.

16 Section 10. The sum of \$4,250,000, or so much thereof as
17 may be necessary and remains unexpended at the close of business
18 on June 30, 2022, from an appropriation heretofore made for
19 such purpose in Article 127, Section 380 of Public Act 102-
20 0017, as amended, is reappropriated from the State Coronavirus
21 Urgent Remediation Emergency Fund to the Illinois Student
22 Assistance Commission for the Golden Apple Accelerators

1 Program, for purposes permitted by Section 9901 of the American
2 Rescue Plan Act of 2021 and related federal guidance.

3 Section 999. Effective Date. This Act takes effect July
4 1, 2022.
