1 AN ACT concerning appropriations.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5 Section 5. The following named amounts, or so much thereof 6 as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated from the General Revenue 7 8 Fund to the Illinois Community College Board for ordinary and 9 contingent expenses: 10 11 12 For State Contributions to Social 13 14 15 16 17 18 19 20 21 For Operation of Automotive Equipment .......................3,700 \$2,477,800 22 Total

- 1 Section 10. The sum of \$1,148,000, or so much thereof as
- 2 may be necessary, is appropriated from the General Revenue Fund
- 3 to Illinois Community College Board for costs associated with
- 4 administering high school equivalency tests.
- 5 Section 15. The sum of \$3,000,000, or so much thereof as
- 6 may be necessary, is appropriated from the General Revenue Fund
- 7 to the Illinois Community College Board for grants to the
- 8 alternative schools network and other providers.
- 9 Section 20. The sum of \$150,000 or so much thereof as may
- 10 be necessary, is appropriated from the General Revenue Fund to
- 11 the Illinois Community College Board for support of the P-20
- 12 Council.
- 13 Section 25. The sum of \$60,200, or so much thereof as may
- 14 be necessary, is appropriated from the General Revenue Fund to
- the Illinois Community College Board for awarding scholarships
- 16 to qualifying graduates of the Lincoln's Challenge Program.
- Section 30. The sum of \$13,928,700, or so much thereof as
- 18 may be necessary, is appropriated from the General Revenue Fund
- 19 to the Illinois Community College Board for the City Colleges
- of Chicago for educational-related expenses.

1	Section 35. The following named amounts, or so much thereof
2	as may be necessary, respectively, are appropriated from the
3	General Revenue Fund to the Illinois Community College Board
4	for distribution to qualifying public community colleges for
5	the purposes specified:
6	Small College Grants548,400
7	Performance Funding Grants359,000

Section 40. The sum of \$560,300, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Community College Board for costs associated with the development, support or administration of the Illinois Longitudinal Data System.

Section 45. The sum of \$1,457,900, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Community College Board for grants to operate an educational facility in the former community college district #541 in East St. Louis.

Section 50. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Community College Board for costs associated

- 1 with grants for transitional math and English development.
- 2 Section 55. The sum of \$23,794,400, or so much thereof as
- 3 may be necessary, is appropriated from the General Revenue Fund
- 4 to the Illinois Community College Board for all costs
- 5 associated with the bridge and workforce programs.
- 6 Section 60. The following named amounts, or so much thereof
- 7 as may be necessary, are appropriated to the Illinois Community
- 8 College Board for all costs associated with career and
- 9 technical education activities:

- 13 Section 65. The following named amounts, or so much of
- 14 those amounts as may be necessary, for the objects and purposes
- named, are appropriated to the Illinois Community College Board
- 16 for adult education and literacy activities:

- 1 Section 75. The sum of \$100,000, or so much thereof as may be necessary, is appropriated from the ICCB Research and 2 Technology Fund to the Illinois Community College Board for 3 costs associated with maintaining and updating instructional 4
- 5 technology.
- 6 Section 80. The sum of \$100,000, or so much thereof as may 7 be necessary, is appropriated from the High School Equivalency 8 Testing Fund to the Illinois Community College Board for costs 9 associated with administering high school equivalency tests.
- 10 Section 85. The sum of \$10,000,000, or so much thereof as 11 may be necessary, is appropriated from the Illinois Community 12 College Board Contracts and Grants Fund to the Illinois Community College Board to be expended under the terms and 13 14 conditions associated with the moneys being received, including 15 prior year expenditures.
- Section 90. The sum of \$525,000, or so much thereof as may 16 17 be necessary, is appropriated from the ICCB Federal Trust Fund 18 to the Illinois Community College Board for the ordinary and 19 contingent expenses of the Board.
- 20 Section 95. The sum of \$1,600,000, or so much thereof as may be necessary, is appropriated from the ICCB Adult Education 21

- 1 Fund to the Illinois Community College Board for operational
- 2 expenses associated with administration of adult education and
- 3 literacy activities.
- 4 Section 100. The sum of \$4,264,400, or so much thereof as
- 5 may be necessary, is appropriated from the General Revenue Fund
- 6 to the Illinois Community College Board to reimburse colleges
- 7 for costs associated with the Illinois Veterans Grant and
- 8 Illinois National Guard Grant.
- 9 Section 105. The sum of \$27,000,000, or so much thereof as
- 10 may be necessary, is appropriated from the Illinois Community
- 11 College Board Contracts and Grants Fund to the Illinois
- 12 Community College Board for grants, contracts, and
- 13 administrative expenses of the Governor's Emergency Education
- 14 Relief Fund award.
- 15 Section 110. The sum of \$50,000,000, or so much thereof
- 16 as may be necessary, is appropriated from the Illinois
- 17 Community College Board Contracts and Grants Fund to the
- 18 Illinois Community College Board for grants and administrative
- 19 costs associated with early childhood programs.
- Section 115. The sum of \$25,000,000, or so much thereof as
- 21 may be necessary, is appropriated from the General Revenue Fund

- 1 to the Illinois Community College Board for the Pipeline for
- 2 Advancement of the Healthcare (PATH) Workforce Program.
- 3 Section 120. The sum of \$150,000, or so much thereof as may
- 4 be necessary, is appropriated from the General Revenue Fund to
- 5 the Illinois Community College Board for operational expenses
- 6 associated with the PATH Workforce Program.

#### 7 ARTICLE 2

- Section 5. The amount of \$10,000,000, or so much thereof 8 9 as may be necessary and remains unexpended at the close of business on June 30, 2022, from an appropriation heretofore 10 made for such purpose in Article 127, Section 195 of Public Act 11 102-0017, as amended, is reappropriated from the State 12 13 Coronavirus Urgent Remediation Emergency Fund to the Illinois 14 Community College Board for costs associated with implementing 15 college bridge programs for purposes permitted by Section 9901 of the American Rescue Plan Act of 2021 and related federal 16 17 quidance.
- 18 Section 999. Effective Date. This Act takes effect July
- 19 1, 2022.
