Introduced 3/10/2021, by Sen. Win Stoller

SYNOPSIS AS INTRODUCED:

ILCON Art. IV, Sec. 8

Amends the Legislature Article of the Illinois Constitution. Provides that no legislative action may be initiated on any bill in either house of the General Assembly unless such bill was introduced in that house no sooner than 14 days prior to the commencement of such action. Effective upon being declared adopted.

3	RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL
4	ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF
5	REPRESENTATIVES CONCURRING HEREIN, that there shall be
6	submitted to the electors of the State for adoption or
7	rejection at the general election next occurring at least 6
8	months after the adoption of this resolution a proposition to
9	amend the Illinois Constitution in Article IV by changing
10	Section 8 as follows:
11	ARTICLE IV
12	THE LEGISLATURE
13	(ILCON Art. IV, Sec. 8)
14	SECTION 8. PASSAGE OF BILLS
15	(a) The enacting clause of the laws of this State shall be:
16	"Be it enacted by the People of the State of Illinois,
17	represented in the General Assembly."
18	(b) The General Assembly shall enact laws only by bill.
19	Bills may originate in either house, but may be amended or
20	rejected by the other.
21	(c) No bill shall become a law without the concurrence of a

	majority of the members elected to each house. Final passage

- of two members, and in the House at the request of five 1
- 2 members, a record vote may be taken on any other occasion. A
- 3 record vote is a vote by yeas and nays entered on the journal.
- (d) A bill shall be read by title on three different days
- 5 in each house. A bill and each amendment thereto shall be
- reproduced and placed on the desk of each member before final 6
- 7 passage.
- 8 Bills, except bills for appropriations and for the
- 9 codification, revision or rearrangement of laws, shall be
- 10 confined to one subject. Appropriation bills shall be limited
- 11 to the subject of appropriations.
- 12 A bill expressly amending a law shall set forth completely
- 13 the sections amended.
- The Speaker of the House of Representatives and the 14
- 15 President of the Senate shall sign each bill that passes both
- 16 houses to certify that the procedural requirements for passage
- 17 have been met.
- (e) No legislative action may be initiated on any bill in 18
- 19 either house of the General Assembly unless such bill was
- 20 introduced in that house no sooner than 14 days prior to the
- commencement of such action. 21
