6 Section 10. The Executive Director of the Lake County 7 Forest Preserve District shall obtain a certified copy of this 8 Act within 60 days after its effective date and shall record 9 the certified document in the Recorder's Office in the county 10 in which the land is located.

Section 99. Effective date. This Act takes effect upon becoming law.".
