SYNOPSIS AS INTRODUCED:

305 ILCS 5/5-5.05

Amends the Medical Assistance Article of the Illinois Public Aid Code. Provides that any freestanding psychiatric hospital located in Peoria County, for which construction commenced on or after January 1, 2023, shall be paid the inpatient per diem rate of no less than \$630 for dates of service on and after January 1, 2025. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Illinois Public Aid Code is amended by 5 changing Section 5-5.05 as follows:

8 (a) On and after July 1, 2008, the inpatient, per diem rate 9 to be paid to a hospital for inpatient psychiatric services 10 shall be \$363.77.

18 (b-5) Notwithstanding any other provision of this Section, 19 and subject to appropriation, the inpatient, per diem rate to 20 be paid to all safety-net hospitals for inpatient psychiatric 21 services on and after January 1, 2021 shall be at least \$630.

(b-10) Notwithstanding any other provision of this Section, effective with dates of service on and after January 1, 2022, any general acute care hospital with more than 9,500 inpatient psychiatric Medicaid days in any calendar year shall be paid the inpatient per diem rate of no less than \$630. - 4 - LRB103 27711 KTG 54088 b

1 <u>(b-15)</u> Notwithstanding any other provision of this 2 <u>Section, any freestanding psychiatric hospital located in</u> 3 <u>Peoria County, for which construction commenced on or after</u> 4 <u>January 1, 2023, shall be paid the inpatient per diem rate of</u> 5 <u>no less than \$630 for dates of service on and after January 1,</u> 6 2025.

7 (c) No rules shall be promulgated to implement this 8 Section. For purposes of this Section, "rules" is given the 9 meaning contained in Section 1-70 of the Illinois 10 Administrative Procedure Act.

(d) This Section shall not be in effect during any period of time that the State has in place a fully operational hospital assessment plan that has been approved by the Centers for Medicare and Medicaid Services of the U.S. Department of Health and Human Services.

(e) On and after July 1, 2012, the Department shall reduce any rate of reimbursement for services or other payments or alter any methodologies authorized by this Code to reduce any rate of reimbursement for services or other payments in accordance with Section 5-5e.
