SYNOPSIS AS INTRODUCED:

70 ILCS 3615/2.10a new 30 ILCS 805/8.47 new

Amends the Regional Transportation Authority Act. Provides that, after the effective date of the amendatory Act, a Service Board may not enter into a contract or contract amendment to purchase a bus that is not a zero-emission bus for the purpose of the Service Board's transit bus fleet. Amends the State Mandates Act to require implementation without reimbursement. Effective immediately.

4	Section 5. The Regional Transportation Authority Act is
5	amended by adding Section 2.10a as follows:

7	Sec. 2.10a. Zero-emission buses.
8	(a) As used in this Section:
9	"Zero-emission bus" means a bus that is:
10	(1) designed to carry more than 10 passengers and is
11	used to carry passengers for compensation.
12	(2) a zero-emission vehicle; and
13	(3) not a taxi.
14	"Zero-emission vehicle" means a fuel cell or electric

AN ACT concerning local government.

(1) is a motor vehicle;

vehicle that:

- 17 (2) is made by a commercial manufacturer;
- (3) is manufactured primarily for use on public 18 streets, roads, and highways; 19
