All agreements entered into 19 pursuant to this Section shall be subject to the written 20 approval of the Director of Natural Resources.

(b) Subject to appropriation, the Department of Natural
 Resources may use State resources for the management,
 maintenance, and operation of the real property conveyed to
 the Prairie Band Potawatomi Nation by this amendatory Act in
