Creates the County Co-Responder Pilot Program Division in the Counties Code. Provides that each county sheriff's office may establish, subject to appropriation, a co-responder unit by no later than 6 months after the effective date of the amendatory Act. Provides that, in addition to other responsibilities, the unit's social workers are responsible for conducting follow-up visits for victims who may benefit from mental or behavioral health services. Provides that the unit's primary area of focus shall be victim assistance. Includes other provisions relating to establishment of the units, duties of the unit, unit training, and privileged or confidential communications. Repeals the Division on January 1, 2029.

- (b) Along with the duties described in Sections 3-16015 2 and 3-16020, the unit's social workers are responsible for 3 conducting follow-up visits for victims who may benefit from 4 mental or behavioral health services. The unit shall utilize 5 community resources, including services provided through the 6 7 Department of Human Services and social workers in juvenile 8 and adult investigations, to connect individuals with 9 appropriate services.

- 13 <u>Sec. 3-16015. Duties. The duties of the unit shall</u>
 14 <u>include, but shall not be limited to:</u>
 - (1) serving as a resource to a department's community to identify and coordinate the social services available to residents who are victims of criminal acts;
 - (2) networking with area social service agencies to develop a community-mutual resource system and wrap-around services (a team-based, collaborative case management approach) for victims in need of social service assistance;
 - (3) fostering relationships with community organizations, including, but not limited to, area hospitals, school districts, juvenile justice system, and

| 5 | Sec. 3-16020. Social workers. |
| 6 | (a) Unit social workers may be referred to as victim |
| 7 | service specialists. Social workers are responsible for |
| 8 | working as a team to provide trauma-informed crisis |
| 9 | intervention, case management, advocacy, and ongoing emotional |
| 10 | support to the victims of all crimes, with extra attention to |
| 11 | crimes that cause a high level of victim trauma. |
| 12 | (b) Unit social workers involved in a case under adult |
| 13 | investigations: |
| 14 | (1) work with domestic violence investigators; |
| 15 | (2) assist victims with finding safe housing, |
| 16 | transportation, and legal assistance; |
| 17 | (3) provide other needed resources for victims and |
| 18 | their families, including working with children who |
| 19 | witness or experience domestic violence; |
| 20 | (4) assist victims and their children in setting up |

Sec. 3-16025. Training. All unit employees shall receive crisis intervention training and integrating communications, assessment, and tactics training. Integrating communications, assessment, and tactics training shall be designed for situations involving persons who are unarmed or are armed with weapons and who may be experiencing a mental health or other crisis. The training described in this Section shall incorporate different skill sets into a unified training approach that emphasizes scenario-based exercises, as well as lecture and case study opportunities.

19 (55 ILCS 5/3-16030 new)

Sec. 3-16030. Privileged or confidential communications.

Nothing contained in this Division shall be construed to impair or limit the confidentiality of communications otherwise protected by law as privileged or confidential, including, but not limited to, information communicated in

- 1 confidence to a social worker or social work intern who works under the direct supervision of a social worker. A social 2 3 worker may not be subjected to adverse employment action, the 4 threat of adverse employment action, or any manner of 5 discrimination because the employee is acting or has acted to 6 protect communications as privileged or confidential pursuant 7 to applicable provisions of State or federal law, rule, or 8 regulation.
