**SYNOPSIS AS INTRODUCED:**

415 ILCS 5/22.12

from Ch. 111 1/2, par. 1022.12

Amends the Environmental Protection Act. Deletes provisions requiring owners of underground storage tanks containing hazardous waste to register the tanks with the Illinois Environmental Protection Agency and provide the Agency with information concerning the contents of the tanks. Deletes a provision requiring the owners of registered tanks to notify the Agency of any change in registration information or of the removal the tank from service.

A BILL FOR

1           AN ACT concerning safety.

2           **Be it enacted by the People of the State of Illinois,**  
3           **represented in the General Assembly:**

4           Section 5. The Environmental Protection Act is amended by  
5           changing Section 22.12 as follows:

6           (415 ILCS 5/22.12) (from Ch. 111 1/2, par. 1022.12)

7           Sec. 22.12. ~~(a)~~ The Agency shall coordinate with the  
8           Office of the State Fire Marshal in the administration of the  
9           Leaking Underground Storage Tank program, as established in  
10          Subtitle I of the Hazardous and Solid Waste Amendments of 1984  
11          (P.L. 98-616), as amended, of the Resource Conservation and  
12          Recovery Act of 1976 (P.L. 94-580). The Agency shall act as the  
13          lead agency in the formulation of regulations and policies,  
14          and shall be responsible for groundwater monitoring and any  
15          necessary site cleanup requirements encountered under the  
16          Resource Conservation and Recovery Act of 1976, the  
17          Comprehensive Environmental Response Compensation and  
18          Liability Act, or the State "Clean Illinois" program.

13      ~~(e) A person who is the owner of an underground storage~~  
14      ~~tank containing hazardous waste the contents of which are~~  
15      ~~changed routinely shall indicate all the materials which are~~  
16      ~~stored in the tank on the registration form. A person~~  
17      ~~providing the information described in this subsection is not~~  
18      ~~required to notify the Agency of changes in the contents of the~~  
19      ~~tank unless the material to be stored in the tank differs from~~  
20      ~~the information provided on the registration form.~~
