SYNOPSIS AS INTRODUCED:

105 ILCS 5/10-20.81
105 ILCS 5/34-18.75

Amends the School Code. In provisions concerning identification cards and suicide prevention information, provides that each school district that serves pupils in any of grades 6 through 12 and that issues an identification card to school employees serving any of grades 6 through 12 shall provide on the identification card the same contact information concerning suicide prevention that is required to be provided on a pupil's identification card.

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The School Code is amended by changing Sections
5 10-20.81 and 34-18.75 as follows:

6 (105 ILCS 5/10-20.81)

7 Sec. 10-20.81. Identification cards; suicide prevention
8 information.

9 (a) Each school district that serves pupils in any of
10 grades 6 through 12 and that issues an identification card to
11 pupils in any of grades 6 through 12 shall provide contact
12 information for the National Suicide Prevention Lifeline
13 (988), the Crisis Text Line, and the Safe2Help Illinois
14 helpline on the identification card. The contact information
15 shall identify each helpline that may be contacted through
16 text messaging. The contact information shall be included in
17 the school's student handbook and also the student planner if
18 a student planner is custom printed by the school for
19 distribution to pupils in any of grades 6 through 12.

20 (b) Each school district that serves pupils in any of
21 grades 6 through 12 and that issues an identification card to
22 school employees serving any of grades 6 through 12 shall
23 provide on the identification card the same contact

8 (a) If the school district issues an identification card
9 to pupils in any of grades 6 through 12, the district shall
10 provide contact information for the National Suicide
11 Prevention Lifeline (988), the Crisis Text Line, and the
12 Safe2Help Illinois helpline on the identification card. The
13 contact information shall identify each helpline that may be
14 contacted through text messaging. The contact information
15 shall be included in the school's student handbook and also
16 the student planner if a student planner is custom printed by
17 the school for distribution to pupils in any of grades 6
18 through 12.

19 (b) If the school district issues an identification card
20 to school employees serving any of grades 6 through 12, the
21 district shall provide on the identification card the same
22 contact information that is required to be provided on a
23 pupil's identification card under subsection (a).
