

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The University of Illinois Act is amended by  
5 adding Section 180 as follows:

6 (110 ILCS 305/180 new)

7 Sec. 180. Winter weather emergency closure; educational  
8 support services pay. If a campus is closed due to a city,  
9 county, or State declaration of a winter weather emergency,  
10 the Board of Trustees shall pay to its employees who provide  
11 educational support services to the campus, including, but not  
12 limited to, custodial employees, building maintenance  
13 employees, transportation employees, food service providers,  
14 classroom assistants, or administrative staff, their daily,  
15 regular rate of pay and benefits rendered for the campus  
16 closure if the closure precludes them from performing their  
17 regularly scheduled duties and the employee would have  
18 reported for work but for the closure; however, this  
19 requirement does not apply if the day is rescheduled and the  
20 employee will be paid the employee's daily, regular rate of  
21 pay and benefits for the rescheduled day when services are  
22 rendered.

1 Section 10. The Southern Illinois University Management  
2 Act is amended by adding Section 155 as follows:

3 (110 ILCS 520/155 new)

4 Sec. 155. Winter weather emergency closure; educational  
5 support services pay. If a campus is closed due to a city,  
6 county, or State declaration of a winter weather emergency,  
7 the Board shall pay to its employees who provide educational  
8 support services to the campus, including, but not limited to,  
9 custodial employees, building maintenance employees,  
10 transportation employees, food service providers, classroom  
11 assistants, or administrative staff, their daily, regular rate  
12 of pay and benefits rendered for the campus closure if the  
13 closure precludes them from performing their regularly  
14 scheduled duties and the employee would have reported for work  
15 but for the closure; however, this requirement does not apply  
16 if the day is rescheduled and the employee will be paid the  
17 employee's daily, regular rate of pay and benefits for the  
18 rescheduled day when services are rendered.

19 Section 15. The Chicago State University Law is amended by  
20 adding Section 5-265 as follows:

21 (110 ILCS 660/5-265 new)

22 Sec. 5-265. Winter weather emergency closure; educational  
23 support services pay. If a campus is closed due to a city,

1 county, or State declaration of a winter weather emergency,  
2 the Board shall pay to its employees who provide educational  
3 support services to the campus, including, but not limited to,  
4 custodial employees, building maintenance employees,  
5 transportation employees, food service providers, classroom  
6 assistants, or administrative staff, their daily, regular rate  
7 of pay and benefits rendered for the campus closure if the  
8 closure precludes them from performing their regularly  
9 scheduled duties and the employee would have reported for work  
10 but for the closure; however, this requirement does not apply  
11 if the day is rescheduled and the employee will be paid the  
12 employee's daily, regular rate of pay and benefits for the  
13 rescheduled day when services are rendered.

14 Section 20. The Eastern Illinois University Law is amended  
15 by adding Section 10-270 as follows:

16 (110 ILCS 665/10-270 new)

17 Sec. 10-270. Winter weather emergency closure; educational  
18 support services pay. If a campus is closed due to a city,  
19 county, or State declaration of a winter weather emergency,  
20 the Board shall pay to its employees who provide educational  
21 support services to the campus, including, but not limited to,  
22 custodial employees, building maintenance employees,  
23 transportation employees, food service providers, classroom  
24 assistants, or administrative staff, their daily, regular rate

1 of pay and benefits rendered for the campus closure if the  
2 closure precludes them from performing their regularly  
3 scheduled duties and the employee would have reported for work  
4 but for the closure; however, this requirement does not apply  
5 if the day is rescheduled and the employee will be paid the  
6 employee's daily, regular rate of pay and benefits for the  
7 rescheduled day when services are rendered.

8 Section 25. The Governors State University Law is amended  
9 by adding Section 15-265 as follows:

10 (110 ILCS 670/15-265 new)

11 Sec. 15-265. Winter weather emergency closure; educational  
12 support services pay. If a campus is closed due to a city,  
13 county, or State declaration of a winter weather emergency,  
14 the Board shall pay to its employees who provide educational  
15 support services to the campus, including, but not limited to,  
16 custodial employees, building maintenance employees,  
17 transportation employees, food service providers, classroom  
18 assistants, or administrative staff, their daily, regular rate  
19 of pay and benefits rendered for the campus closure if the  
20 closure precludes them from performing their regularly  
21 scheduled duties and the employee would have reported for work  
22 but for the closure; however, this requirement does not apply  
23 if the day is rescheduled and the employee will be paid the  
24 employee's daily, regular rate of pay and benefits for the

1 rescheduled day when services are rendered.

2 Section 30. The Illinois State University Law is amended  
3 by adding Section 20-275 as follows:

4 (110 ILCS 675/20-275 new)

5 Sec. 20-275. Winter weather emergency closure; educational  
6 support services pay. If a campus is closed due to a city,  
7 county, or State declaration of a winter weather emergency,  
8 the Board shall pay to its employees who provide educational  
9 support services to the campus, including, but not limited to,  
10 custodial employees, building maintenance employees,  
11 transportation employees, food service providers, classroom  
12 assistants, or administrative staff, their daily, regular rate  
13 of pay and benefits rendered for the campus closure if the  
14 closure precludes them from performing their regularly  
15 scheduled duties and the employee would have reported for work  
16 but for the closure; however, this requirement does not apply  
17 if the day is rescheduled and the employee will be paid the  
18 employee's daily, regular rate of pay and benefits for the  
19 rescheduled day when services are rendered.

20 Section 35. The Northeastern Illinois University Law is  
21 amended by adding Section 25-270 as follows:

22 (110 ILCS 680/25-270 new)

1       Sec. 25-270. Winter weather emergency closure; educational  
2 support services pay. If a campus is closed due to a city,  
3 county, or State declaration of a winter weather emergency,  
4 the Board shall pay to its employees who provide educational  
5 support services to the campus, including, but not limited to,  
6 custodial employees, building maintenance employees,  
7 transportation employees, food service providers, classroom  
8 assistants, or administrative staff, their daily, regular rate  
9 of pay and benefits rendered for the campus closure if the  
10 closure precludes them from performing their regularly  
11 scheduled duties and the employee would have reported for work  
12 but for the closure; however, this requirement does not apply  
13 if the day is rescheduled and the employee will be paid the  
14 employee's daily, regular rate of pay and benefits for the  
15 rescheduled day when services are rendered.

16       Section 40. The Northern Illinois University Law is  
17 amended by adding Section 30-280 as follows:

18       (110 ILCS 685/30-280 new)

19       Sec. 30-280. Winter weather emergency closure; educational  
20 support services pay. If a campus is closed due to a city,  
21 county, or State declaration of a winter weather emergency,  
22 the Board shall pay to its employees who provide educational  
23 support services to the campus, including, but not limited to,  
24 custodial employees, building maintenance employees,

1 transportation employees, food service providers, classroom  
2 assistants, or administrative staff, their daily, regular rate  
3 of pay and benefits rendered for the campus closure if the  
4 closure precludes them from performing their regularly  
5 scheduled duties and the employee would have reported for work  
6 but for the closure; however, this requirement does not apply  
7 if the day is rescheduled and the employee will be paid the  
8 employee's daily, regular rate of pay and benefits for the  
9 rescheduled day when services are rendered.

10 Section 45. The Western Illinois University Law is amended  
11 by adding Section 35-275 as follows:

12 (110 ILCS 690/35-275 new)

13 Sec. 35-275. Winter weather emergency closure; educational  
14 support services pay. If a campus is closed due to a city,  
15 county, or State declaration of a winter weather emergency,  
16 the Board shall pay to its employees who provide educational  
17 support services to the campus, including, but not limited to,  
18 custodial employees, building maintenance employees,  
19 transportation employees, food service providers, classroom  
20 assistants, or administrative staff, their daily, regular rate  
21 of pay and benefits rendered for the campus closure if the  
22 closure precludes them from performing their regularly  
23 scheduled duties and the employee would have reported for work  
24 but for the closure; however, this requirement does not apply

1 if the day is rescheduled and the employee will be paid the  
2 employee's daily, regular rate of pay and benefits for the  
3 rescheduled day when services are rendered.

4 Section 50. The Public Community College Act is amended by  
5 adding Section 3-29.26 as follows:

6 (110 ILCS 805/3-29.26 new)

7 Sec. 3-29.26. Winter weather emergency closure;  
8 educational support services pay. If a campus is closed due to  
9 a city, county, or State declaration of a winter weather  
10 emergency, the board shall pay to its employees who provide  
11 educational support services to the campus, including, but not  
12 limited to, custodial employees, building maintenance  
13 employees, transportation employees, food service providers,  
14 classroom assistants, or administrative staff, their daily,  
15 regular rate of pay and benefits rendered for the campus  
16 closure if the closure precludes them from performing their  
17 regularly scheduled duties and the employee would have  
18 reported for work but for the closure; however, this  
19 requirement does not apply if the day is rescheduled and the  
20 employee will be paid the employee's daily, regular rate of  
21 pay and benefits for the rescheduled day when services are  
22 rendered.
