1 AMENDMENT TO SENATE BILL 331

2 AMENDMENT NO. _____. Amend Senate Bill 331 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The University of Illinois Act is amended by
5 adding Section 180 as follows:

6 (110 ILCS 305/180 new)

7 Sec. 180. Winter weather emergency closure; educational
8 support services pay. If a campus is closed due to a city,
9 county, or State declaration of a winter weather emergency,
10 the Board of Trustees shall pay to its employees who provide
11 educational support services to the campus, including, but not
12 limited to, custodial employees, building maintenance
13 employees, transportation employees, food service providers,
14 classroom assistants, or administrative staff, their daily,
15 regular rate of pay and benefits rendered for the campus
16 closure if the closure precludes them from performing their

1 regularly scheduled duties and the employee would have
2 reported for work but for the closure; however, this
3 requirement does not apply if the day is rescheduled and the
4 employee will be paid the employee's daily, regular rate of
5 pay and benefits for the rescheduled day when services are
6 rendered.

7 Section 10. The Southern Illinois University Management
8 Act is amended by adding Section 155 as follows:

9 (110 ILCS 520/155 new)

10 Sec. 155. Winter weather emergency closure; educational
11 support services pay. If a campus is closed due to a city,
12 county, or State declaration of a winter weather emergency,
13 the Board shall pay to its employees who provide educational
14 support services to the campus, including, but not limited to,
15 custodial employees, building maintenance employees,
16 transportation employees, food service providers, classroom
17 assistants, or administrative staff, their daily, regular rate
18 of pay and benefits rendered for the campus closure if the
19 closure precludes them from performing their regularly
20 scheduled duties and the employee would have reported for work
21 but for the closure; however, this requirement does not apply
22 if the day is rescheduled and the employee will be paid the
23 employee's daily, regular rate of pay and benefits for the
24 rescheduled day when services are rendered.

1 Section 15. The Chicago State University Law is amended by
2 adding Section 5-265 as follows:

3 (110 ILCS 660/5-265 new)

4 Sec. 5-265. Winter weather emergency closure; educational
5 support services pay. If a campus is closed due to a city,
6 county, or State declaration of a winter weather emergency,
7 the Board shall pay to its employees who provide educational
8 support services to the campus, including, but not limited to,
9 custodial employees, building maintenance employees,
10 transportation employees, food service providers, classroom
11 assistants, or administrative staff, their daily, regular rate
12 of pay and benefits rendered for the campus closure if the
13 closure precludes them from performing their regularly
14 scheduled duties and the employee would have reported for work
15 but for the closure; however, this requirement does not apply
16 if the day is rescheduled and the employee will be paid the
17 employee's daily, regular rate of pay and benefits for the
18 rescheduled day when services are rendered.

19 Section 20. The Eastern Illinois University Law is amended
20 by adding Section 10-270 as follows:

21 (110 ILCS 665/10-270 new)

22 Sec. 10-270. Winter weather emergency closure; educational

1 support services pay. If a campus is closed due to a city,
2 county, or State declaration of a winter weather emergency,
3 the Board shall pay to its employees who provide educational
4 support services to the campus, including, but not limited to,
5 custodial employees, building maintenance employees,
6 transportation employees, food service providers, classroom
7 assistants, or administrative staff, their daily, regular rate
8 of pay and benefits rendered for the campus closure if the
9 closure precludes them from performing their regularly
10 scheduled duties and the employee would have reported for work
11 but for the closure; however, this requirement does not apply
12 if the day is rescheduled and the employee will be paid the
13 employee's daily, regular rate of pay and benefits for the
14 rescheduled day when services are rendered.

15 Section 25. The Governors State University Law is amended
16 by adding Section 15-265 as follows:

17 (110 ILCS 670/15-265 new)

18 Sec. 15-265. Winter weather emergency closure; educational
19 support services pay. If a campus is closed due to a city,
20 county, or State declaration of a winter weather emergency,
21 the Board shall pay to its employees who provide educational
22 support services to the campus, including, but not limited to,
23 custodial employees, building maintenance employees,
24 transportation employees, food service providers, classroom

1 assistants, or administrative staff, their daily, regular rate
2 of pay and benefits rendered for the campus closure if the
3 closure precludes them from performing their regularly
4 scheduled duties and the employee would have reported for work
5 but for the closure; however, this requirement does not apply
6 if the day is rescheduled and the employee will be paid the
7 employee's daily, regular rate of pay and benefits for the
8 rescheduled day when services are rendered.

9 Section 30. The Illinois State University Law is amended
10 by adding Section 20-275 as follows:

11 (110 ILCS 675/20-275 new)

12 Sec. 20-275. Winter weather emergency closure; educational
13 support services pay. If a campus is closed due to a city,
14 county, or State declaration of a winter weather emergency,
15 the Board shall pay to its employees who provide educational
16 support services to the campus, including, but not limited to,
17 custodial employees, building maintenance employees,
18 transportation employees, food service providers, classroom
19 assistants, or administrative staff, their daily, regular rate
20 of pay and benefits rendered for the campus closure if the
21 closure precludes them from performing their regularly
22 scheduled duties and the employee would have reported for work
23 but for the closure; however, this requirement does not apply
24 if the day is rescheduled and the employee will be paid the

1 employee's daily, regular rate of pay and benefits for the
2 rescheduled day when services are rendered.

3 Section 35. The Northeastern Illinois University Law is
4 amended by adding Section 25-270 as follows:

5 (110 ILCS 680/25-270 new)

6 Sec. 25-270. Winter weather emergency closure; educational
7 support services pay. If a campus is closed due to a city,
8 county, or State declaration of a winter weather emergency,
9 the Board shall pay to its employees who provide educational
10 support services to the campus, including, but not limited to,
11 custodial employees, building maintenance employees,
12 transportation employees, food service providers, classroom
13 assistants, or administrative staff, their daily, regular rate
14 of pay and benefits rendered for the campus closure if the
15 closure precludes them from performing their regularly
16 scheduled duties and the employee would have reported for work
17 but for the closure; however, this requirement does not apply
18 if the day is rescheduled and the employee will be paid the
19 employee's daily, regular rate of pay and benefits for the
20 rescheduled day when services are rendered.

21 Section 40. The Northern Illinois University Law is
22 amended by adding Section 30-280 as follows:

1 (110 ILCS 685/30-280 new)

2 Sec. 30-280. Winter weather emergency closure; educational
3 support services pay. If a campus is closed due to a city,
4 county, or State declaration of a winter weather emergency,
5 the Board shall pay to its employees who provide educational
6 support services to the campus, including, but not limited to,
7 custodial employees, building maintenance employees,
8 transportation employees, food service providers, classroom
9 assistants, or administrative staff, their daily, regular rate
10 of pay and benefits rendered for the campus closure if the
11 closure precludes them from performing their regularly
12 scheduled duties and the employee would have reported for work
13 but for the closure; however, this requirement does not apply
14 if the day is rescheduled and the employee will be paid the
15 employee's daily, regular rate of pay and benefits for the
16 rescheduled day when services are rendered.

17 Section 45. The Western Illinois University Law is amended
18 by adding Section 35-275 as follows:

19 (110 ILCS 690/35-275 new)

20 Sec. 35-275. Winter weather emergency closure; educational
21 support services pay. If a campus is closed due to a city,
22 county, or State declaration of a winter weather emergency,
23 the Board shall pay to its employees who provide educational
24 support services to the campus, including, but not limited to,

1 custodial employees, building maintenance employees,
2 transportation employees, food service providers, classroom
3 assistants, or administrative staff, their daily, regular rate
4 of pay and benefits rendered for the campus closure if the
5 closure precludes them from performing their regularly
6 scheduled duties and the employee would have reported for work
7 but for the closure; however, this requirement does not apply
8 if the day is rescheduled and the employee will be paid the
9 employee's daily, regular rate of pay and benefits for the
10 rescheduled day when services are rendered.

11 Section 50. The Public Community College Act is amended by
12 adding Section 3-29.26 as follows:

13 (110 ILCS 805/3-29.26 new)

14 Sec. 3-29.26. Winter weather emergency closure;
15 educational support services pay. If a campus is closed due to
16 a city, county, or State declaration of a winter weather
17 emergency, the board shall pay to its employees who provide
18 educational support services to the campus, including, but not
19 limited to, custodial employees, building maintenance
20 employees, transportation employees, food service providers,
21 classroom assistants, or administrative staff, their daily,
22 regular rate of pay and benefits rendered for the campus
23 closure if the closure precludes them from performing their
24 regularly scheduled duties and the employee would have

1 reported for work but for the closure; however, this
2 requirement does not apply if the day is rescheduled and the
3 employee will be paid the employee's daily, regular rate of
4 pay and benefits for the rescheduled day when services are
5 rendered."
