1 AMENDMENT TO SENATE BILL 684

2 AMENDMENT NO. _____. Amend Senate Bill 684 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Airport Authorities Act is amended by
5 adding Section 2.7.3 as follows:

6 (70 ILCS 5/2.7.3 new)

7 Sec. 2.7.3. Central Illinois Regional Airport Authority.

8 (a) The Central Illinois Regional Airport Authority is
9 hereby established, the territory of which shall include all
10 of the territory within the corporate limits of McLean County.
11 Within 30 days after the initial appointments have been made
12 under subsection (c), the Authority board shall notify the
13 office of the Secretary of State of the establishment of the
14 Central Illinois Regional Airport Authority, and the Secretary
15 of State shall issue a certificate of incorporation to the
16 Authority. Upon the issuance of a certificate of

1 incorporation, the Central Illinois Regional Airport Authority
2 is an organized airport authority under this Act.

3 (b) If all of the airport facilities of an existing
4 airport authority are situated within McLean County on the
5 effective date of this amendatory Act of the 103rd General
6 Assembly, that existing airport authority is dissolved upon
7 the establishment of the Central Illinois Regional Airport
8 Authority. Upon dissolution, the rights to all property,
9 assets, and liabilities, including bonded indebtedness, of the
10 existing airport authority is assumed by the Central Illinois
11 Regional Airport Authority.

12 (c) The Board of Commissioners of the Central Illinois
13 Regional Airport Authority shall consist of the following
14 commissioners who shall reside within its corporate limits and
15 shall be appointed as follows:

16 (1) Three commissioners shall be appointed by the
17 county chairman of McLean County. Of the commissioners
18 appointed under this paragraph, one commissioner shall be
19 appointed for a 3-year term, one commissioner shall be
20 appointed for a 4-year term, and one commissioners shall
21 be appointed for a 5-year term, as determined by lot.
22 Their successors shall be appointed for 5-year terms.

23 (2) Two commissioners shall be appointed by the mayor
24 of the City of Bloomington. Of the commissioners appointed
25 under this paragraph, one commissioner shall be appointed
26 for a 3-year term and one commissioner shall be appointed

1 for a 4-year term, as determined by lot. Their successors
2 shall be appointed for 5-year terms.

3 (3) Two commissioners shall be appointed by the mayor
4 of the City of Normal. Of the commissioners appointed
5 under this paragraph, one commissioner shall be appointed
6 for a 4-year term and one commissioner shall be appointed
7 for a 5-year term, as determined by lot. Their successors
8 shall be appointed for 5-year terms.

9 Section 99. Effective date. This Act takes effect upon
10 becoming law.".
