1 AN ACT concerning education.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The School Code is amended by changing Section
24-14 as follows:

6 (105 ILCS 5/24-14) (from Ch. 122, par. 24-14)
7 Sec. 24-14. Termination of contractual continued service
8 by teacher. <u>As used in this Section, "teaching assignment"</u>
9 <u>means any full-time position that requires licensure under</u>
10 Article 21B of this Code.

A teacher, as defined in Section 24-11 of this Code, who 11 has entered into contractual continued service may resign at 12 13 any time by obtaining concurrence of the board or by serving at 14 least 30 days' written notice upon the secretary of the board. During the school term, However, no teacher may resign during 15 16 the school term, without the concurrence of the board, in 17 order to accept another teaching assignment. Outside of a school term, a resignation submitted by any teacher after the 18 19 completion of the school year must be submitted in writing to 20 the secretary of the board a minimum of 30 calendar days prior 21 to the first student attendance day of the following school 22 year or else the teacher will be deemed to have resigned during the school term. Any teacher terminating said service not in 23

accordance with this Section may be referred by the board to 1 2 the State Superintendent of Education. A referral to the State Superintendent for an alleged violation of this Section must 3 include (i) a dated copy of the teacher's resignation letter, 4 5 (ii) a copy of the reporting district's current school year calendar, (iii) proof of employment for the school year at 6 7 issue, (iv) documentation showing that the district's board did not accept the teacher's resignation, and (v) evidence 8 9 that the teacher left the district in order to accept another 10 teaching assignment. If the district intends to submit a 11 referral to the State Superintendent, the district shall 12 submit the referral to the State Superintendent within 10 13 business days after the board denies acceptance of the 14 resignation. The district shall notify the teacher that it submitted the referral to the State Superintendent within 5 15 16 business days after submitting the referral to the State 17 Superintendent. The State Superintendent or his or her designee shall convene an informal evidentiary hearing no 18 19 later than 90 days after receipt of the required documentation from the school district as required in this Section of a 20 21 resolution by the board. The teacher shall receive a written 22 determination from the State Superintendent or his or her 23 designee no later than 14 days after the hearing is completed. If the State Superintendent or his or her designee finds that 24 25 the teacher resigned during the school term without the 26 concurrence of the board to accept another teaching

1 assignment, the State Superintendent must suspend the 2 teacher's license for one calendar year. In lieu of a hearing 3 and finding, the teacher may agree to a lesser licensure 4 sanction at the discretion of the State Superintendent <u>or his</u> 5 <u>or her designee</u>. 6 (Source: P.A. 101-531, eff. 8-23-19; 102-552, eff. 1-1-22.)
