Conviction of any offense defined in Section 4-102 of this Code; 5 8. Violation of Section 11-504 of this Code 6 7 relating to the offense of drag racing; 9. Violation of Chapters 8 and 9 of this Code; 8 9 10. Violation of Section 12-5 of the Criminal Code of 1961 arising from the use of a motor vehicle; 10 11 11. Violation of Section 11-204.1 of this Code relating to aggravated fleeing or attempting to elude a 12 peace police officer; 13 12. Violation of paragraph (1) of subsection (b) of 14

Section 6-507, or a similar law of any other state, relating to the unlawful operation of a commercial motor vehicle;

18 13. Violation of paragraph (a) of Section 11-502 of 19 this Code or a similar provision of a local ordinance if 20 the driver has been previously convicted of a violation 21 of that Section or a similar provision of a local 22 ordinance and the driver was less than 21 years of age at 23 the time of the offense.

24 (b) The Secretary of State shall also immediately revoke 25 the license or permit of any driver in the following 26 situations:

 that the minor has been adjudicated under that Act as

 prescribed in Section 4-103 of this Code;

1 under Section 11-501.1, or 2 or more statutory summary 2 suspensions, or combination of 2 offenses, or of an offense and a statutory summary suspension, arising out of separate 3 4 occurrences, that person, if issued a restricted driving 5 permit, may not operate a vehicle unless it has been equipped 6 with an ignition interlock device as defined in Section 7 1-129.1. The person must pay to the Secretary of State DUI 8 Administration Fund an amount not to exceed \$20 per month. 9 The Secretary shall establish by rule the amount and the procedures, terms, and conditions relating to these fees. If 10 11 the restricted driving permit was issued for employment purposes, then this provision does not apply to the operation 12 of an occupational vehicle owned or leased by that person's 13 employer. In each case the Secretary of State may issue 14 а restricted driving permit for a period he deems appropriate, 15 16 except that the permit shall expire within one year from the 17 date of issuance. 5 (g) The Secretary of State shall not issue a restricted 6 driving permit to a person under the age of 16 years whose 7 driving privileges have been revoked under any provisions of 8 this Code.

9 The Secretary of State shall require the use of (h) ignition interlock devices on all vehicles owned by an 10 11 individual who has been convicted of a second or subsequent offense under Section 11-501 of this Code or a similar 12 provision of a local ordinance. The 13 Secretary shall establish by rule and regulation the procedures for 14 certification and use of the interlock system. 15

16 (i) The Secretary of State may not issue a restricted driving permit for a period of one year after a second or 17 subsequent revocation of driving privileges under clause 18 19 (a)(2) of this Section; however, one year after the date of a second or subsequent revocation of driving privileges under 20 clause (a)(2) of this Section, the Secretary of State may, 21 upon application, issue a restricted driving permit under the 22 23 terms and conditions of subsection (c).

32. Has been convicted of Section 24-1.2 of the Criminal Code of 1961 relating to the aggravated discharge of a firearm if the offender was located in a motor vehicle at the time the firearm was discharged, in which case the suspension shall be for 3 years;

33. Has as a driver, who was less than 21 years of
age on the date of the offense, been convicted a first
time of a violation of paragraph (a) of Section 11-502 of
this Code or a similar provision of a local ordinance;

31 34. Has committed a violation of Section 11-1301.5
32 of this Code;

33 35. Has committed a violation of Section 11-1301.6
34 of this Code;

1 36. Is under the age of 21 years at the time of 2 arrest and has been convicted of not less than 2 offenses 3 against traffic regulations governing the movement of 4 vehicles committed within any 24 month period. No 5 revocation or suspension shall be entered more than 6 6 months after the date of last conviction;

For purposes of paragraphs 5, 9, 10, 12, 14, 19, 25, 26, and 27 of this subsection, license means any driver's license, any traffic ticket issued when the person's driver's license is deposited in lieu of bail, a suspension notice issued by the Secretary of State, a duplicate or corrected driver's license, a probationary driver's license or a temporary driver's license.

The Secretary of State may, as a condition to the issuance of a restricted driving 12 13 permit, require the applicant to participate in a designated driver remedial or rehabilitative program. 14 Secretary of State is authorized to cancel a 15 The 16 restricted driving permit if the permit holder does not 17 successfully complete the program.

18 (c-5) The Secretary of State may, as a condition of the 19 reissuance of a driver's license or permit to an applicant 20 whose driver's license or permit has been suspended before he 21 or she reached the age of 18 years pursuant to any of the 22 provisions of this Section, require the applicant to 23 participate in a driver remedial education course and be 24 retested under Section 6-109 of this Code.

25 (d) This Section is subject to the provisions of the26 Drivers License Compact.

(e) The Secretary of State shall not issue a restricted
driving permit to a person under the age of 16 years whose
driving privileges have been suspended or revoked under any

4 Any driver or operator of a motor vehicle who, (a) 5 having been given a visual or audible signal by a peace 6 officer directing such driver or operator to bring his 7 vehicle to a stop, wilfully fails or refuses to obey such 8 direction, increases his speed, extinguishes his lights, or 9 otherwise flees or attempts to elude the officer, is guilty of a Class A misdemeanor. The signal given by the peace 10 11 officer may be by hand, voice, siren, red or blue light. Provided, the officer giving such signal shall be in police 12 uniform, and, if driving a vehicle, such vehicle shall 13 display illuminated oscillating, rotating or flashing red or 14 blue lights which when used in conjunction with an audible 15 16 horn or siren would indicate the vehicle to be an official police vehicle. Such requirement shall not preclude the use 17 of amber or white oscillating, rotating or flashing lights in 18 19 conjunction with red or blue oscillating, rotating or flashing lights as required in Section 12-215 of Chapter 12. 20

(b) Upon receiving notice of such conviction the Secretary of State shall suspend the drivers license of the person so convicted for a period of not more than 6 months for a first conviction and not more than 12 months for a second conviction.

operator of a motor vehicle who flees or attempts to elude a <u>peace police officer</u>, after being given a visual or audible signal by a <u>peace police officer</u> in the manner prescribed in subsection (a) of Section 11-204 of this Code, and such flight or attempt to elude:

(2) causes bodily injury to any individual; er
(3) causes damage in excess of \$300 to property; or.

Any person convicted of a first violation of this 12 (b) Section shall be guilty of a Class 4 felony. Upon notice of 13 such a conviction the Secretary of State shall forthwith 14 revoke the driver's license of the person so convicted, 15 as 16 provided in Section 6-205 of this Code. Any person convicted of a second or subsequent violation of this Section shall be 17 18 guilty of a Class 3 felony, and upon notice of such a 19 conviction the Secretary of State shall forthwith revoke the driver's license of the person convicted, as provided in 20 Section 6-205 of the Code. 21

(c) The motor vehicle used in a violation of this
Section is subject to seizure and forfeiture as provided in
