- 9 child, brother, or sister of the candidate), your employer,
- 10 your employer's agent or an officer or agent of your union
- 11 from assisting physically disabled voters."
- 12 In addition to the above, if a ballot to be provided to
- 13 an elector pursuant to this Section contains a public
- 14 question described in subsection (b) of Section 28-6 and the
- 15 territory concerning which the question is to be submitted is
- 16 not described on the ballot due to the space limitations of
- 17 such ballot, the election authority shall provide a printed
- 18 copy of a notice of the public question, which shall include
- 19 a description of the territory in the manner required by
- 20 Section 16-7. The notice shall be furnished to the elector
- 21 at the same time the ballot is delivered to the elector.
