b. fixing, controlling, maintaining, limiting, or discontinuing the production, manufacture, mining, sale or supply of any commodity, or the sale or supply of any service, for the purpose or with the effect stated in paragraph a. of subsection (1);

22 c. allocating or dividing customers, territories,

supplies, sales, or markets, functional or geographical, for
any commodity or service; or

3 (1.5) with respect to any product regulated by the 4 <u>Master Settlement Agreement between the states' attorneys</u> 5 <u>general and the tobacco companies, restricting or limiting</u> 6 <u>the promotion, advertising, or display of products</u> 7 <u>manufactured by the person's competitors; or</u>

8 (2) By contract, combination, or conspiracy with one or 9 more other persons unreasonably restrain trade or commerce; 10 or

11 (3) Establish, maintain, use, or attempt to acquire 12 monopoly power over any substantial part of trade or commerce 13 of this State for the purpose of excluding competition or of 14 controlling, fixing, or maintaining prices in such trade or 15 commerce; or

16 (4) Lease or make a sale or contract for sale of goods, 17 wares, merchandise, machinery, supplies, or other commodities, or services (including master antenna television 18 19 service), whether patented or unpatented, for use, consumption, enjoyment, or resale, or fix a price charged 20 21 thereof, or discount from, or rebate upon, such price, on the 22 condition, agreement, or understanding that the lessee or 23 purchaser thereof shall not use or deal in the goods, wares, merchandise, machinery, supplies, or other commodity or 24 25 service (including cable television service or cable television relay service), of a competitor or competitors of 26 the lessor or seller, where the effect of such lease, sale or 27 contract for such sale or such condition, agreement, or 28 29 understanding may be to substantially lessen competition or 30 tend to create a monopoly in any line of commerce; or

31 (5) Being an employee, officer or agent of any foreign 32 government, or an employee, officer or agent of a corporation 33 or other entity which does business with or seeks to do 34 business with any foreign government or instrumentality

thereof; enforce, attempt to enforce, agree to or take action to forward the aims of, any discriminatory practice by the foreign government which is based on race, color, creed, national ancestry or sex or on ethnic or religious grounds, where such conduct, course of conduct, or agreement takes place in whole or in part within the United States and affects business in this State.
