AN ACT concerning higher education.

2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

4 Section 5. The University of Illinois Act is amended by 5 adding Section 25 as follows:

6 (110 ILCS 305/25 new)

Sec. 25. Limitation on tuition increase. This Section 7 8 applies only to those students who first enroll after the 2003-2004 academic year. For 4 continuous academic years 9 following initial enrollment (or for undergraduate programs 10 that require more than 4 years to complete, for the normal 11 time to complete the program, as determined by the 12 13 University), the tuition charged an undergraduate student who is an Illinois resident shall not exceed the amount that the 14 student was charged at the time he or she first enrolled in 15 the University. However, if the student changes majors during 16 this time period, the tuition charged the student shall equal 17 18 the amount the student would have been charged had he or she 19 been admitted to the changed major when he or she first enrolled. 20

Section 10. The Southern Illinois University Management
Act is amended by adding Section 15 as follows:

24 <u>Sec. 15. Limitation on tuition increase. This Section</u> 25 applies only to those students who first enroll after the 26 <u>2003-2004 academic year. For 4 continuous academic years 14 following initial enrollment (or for undergraduate programs 15 that require more than 4 years to complete, for the normal 16 17 time to complete the program, as determined by the 18 University), the tuition charged an undergraduate student who 19 is an Illinois resident shall not exceed the amount that the 20 student was charged at the time he or she first enrolled in the University. However, if the student changes majors during 21 22 this time period, the tuition charged the student shall equal the amount the student would have been charged had he or she 23 24 been admitted to the changed major when he or she first 25 enrolled.

26 Section 20. The Eastern Illinois University Law is 27 amended by adding Section 10-120 as follows:

 30 <u>Section applies only to those students who first enroll after</u>

For 4 continuous academic years 2 following initial enrollment (or for undergraduate programs 3 that require more than 4 years to complete, for the normal 4 time to complete the program, as determined by the University), the tuition charged an undergraduate student who 5 is an Illinois resident shall not exceed the amount that the 6 7 student was charged at the time he or she first enrolled in the University. However, if the student changes majors during 8 this time period, the tuition charged the student shall equal 9 10 the amount the student would have been charged had he or she 11 been admitted to the changed major when he or she first <u>enrolled.</u> 12

Section 25. The Governors State University Law is amended by adding Section 15-120 as follows:

Sec. 15-120. Limitation on tuition increase. This 16 17 Section applies only to those students who first enroll after the 2003-2004 academic year. For 4 continuous academic years 18 following initial enrollment (or for undergraduate programs 19 20 that require more than 4 years to complete, for the normal time to complete the program, as determined by the 21 University), the tuition charged an undergraduate student who 22 is an Illinois resident shall not exceed the amount that the 23 24 student was charged at the time he or she first enrolled in the University. However, if the student changes majors during 25 this time period, the tuition charged the student shall equal 26 27 the amount the student would have been charged had he or she been admitted to the changed major when he or she first 28 29 enrolled.

30 Section 30. The Illinois State University Law is amended 31 by adding Section 20-125 as follows: HB1118 Enrolled

Sec. 20-125. Limitation on tuition increase. This 2 3 Section applies only to those students who first enroll after 4 the 2003-2004 academic year. For 4 continuous academic years following initial enrollment (or for undergraduate programs 5 that require more than 4 years to complete, for the normal 6 time to complete the program, as determined by the 7 University), the tuition charged an undergraduate student who 8 9 is an Illinois resident shall not exceed the amount that the 10 student was charged at the time he or she first enrolled in 11 the University. However, if the student changes majors during 12 this time period, the tuition charged the student shall equal 13 the amount the student would have been charged had he or she been admitted to the changed major when he or she first 14 15 enrolled.

Section 35. The Northeastern Illinois University Law is 16 amended by adding Section 25-120 as follows: 17

Sec. 25-120. Limitation on tuition increase. This 19 20 Section applies only to those students who first enroll after the 2003-2004 academic year. For 4 continuous academic years 21 following initial enrollment (or for undergraduate programs 22 that require more than 4 years to complete, for the normal 23 24 time to complete the program, as determined by the University), the tuition charged an undergraduate student who 25 is an Illinois resident shall not exceed the amount that the 26 27 student was charged at the time he or she first enrolled in the University. However, if the student changes majors during 28 29 this time period, the tuition charged the student shall equal the amount the student would have been charged had he or she 30 been admitted to the changed major when he or she first 31 32 enrolled.

Section 40. The Northern Illinois University Law is

For 4 continuous academic years 23 following initial enrollment (or for undergraduate programs 24 that require more than 4 years to complete, for the normal 25 time to complete the program, as determined by the 26 27 University), the tuition charged an undergraduate student who is an Illinois resident shall not exceed the amount that the 28 29 student was charged at the time he or she first enrolled in the University. However, if the student changes majors during 30 this time period, the tuition charged the student shall equal 31
