- 22 The Illinois Identification Card may be used for
- 23 identification purposes in any lawful situation only by the
- 24 person to whom it was issued. As used in this Act,
- 25 "photograph" means any color photograph or digitally produced
- 26 and captured image of an applicant for an identification
- 27 card. As used in this Act, "signature" means the name of a
- 28 person as written by that person and captured in a manner
- 29 acceptable to the Secretary of State.
- 30 (b) The Secretary of State shall issue a special
- 31 Illinois Identification Card, which shall be known as an

1 Illinois Disabled Person Identification Card, to any natural 2 person who is a resident of the State of Illinois, who is a disabled person as defined in Section 4A of this Act, who 3 4 applies for such card, or renewal thereof. The Secretary of 5 State shall charge no fee to issue such card. The card shall 6 be prepared and supplied by the Secretary of State, and shall 7 include a photograph of the applicant, а designation Illinois Disabled Person 8 indicating that the card is an 9 Identification Card, and shall include a comprehensible designation of the type and classification of the applicant's 10 11 disability as set out in Section 4A of this Act. the applicant so requests, the card shall include a description 12 of the applicant's disability and any information about the 13 applicant's disability or medical history which the Secretary 14 15 determines would be helpful to the applicant in securing 16 emergency medical care. The applicant, upon receipt of such a card and prior to its use for any purpose, shall have 17 18 affixed thereon in the space provided therefor his signature 19 or mark. If a mark is used in lieu of a signature, such mark shall be affixed to the card in the presence of two witnesses 20 21 who attest to the authenticity of the mark. The Illinois 22 Disabled Person Identification Card may be used for 23 identification purposes in any lawful situation by the person 24 to whom it was issued. 25 The Illinois Disabled Person Identification Card may be

used as adequate documentation of disability in lieu of 26 of physician's determination 27 disability or any other documentation of disability whenever any State law requires 28 disabled person provide such documentation of 29 30 disability, however Illinois Disabled an Identification Card shall not qualify the cardholder to 31 32 participate in any program or to receive any benefit which is not available to all persons with 33 like disabilities. 34 Notwithstanding any other provisions of law, an Illinois

- 1 be issued in every county and applications shall be made
- 2 available at, but not limited to, nutrition sites, senior

- 12 (a) The Secretary of State shall issue to every
- 13 qualifying applicant a driver's license as applied for, which
- 14 license shall bear a distinguishing number assigned to the
- licensee, the name, social security number, zip code, date of
- 16 birth, address, and a brief description of the licensee, and
- 17 a space where the licensee may write his usual signature.
- 18 If the licensee is less than 17 years of age, the license
- 19 shall, as a matter of law, be invalid for the operation of
- 20 any motor vehicle during any time the licensee is prohibited
- 21 from being on any street or highway under the provisions of
- 22 the Child Curfew Act.
- 23 Licenses issued shall also indicate the classification

State may undertake additional efforts, 17 Secretary of 18 including education and awareness activities, to promote 19 organ and tissue donation.

- (d) The Secretary of State shall designate on each driver's license issued a space where the licensee may indicate his blood type and RH factor.
- 34 (e) The Secretary of State shall provide that each

- 1 original or renewal driver's license issued to a licensee
- 2 under 21 years of age shall be of a distinct nature from
- 3 those driver's licenses issued to individuals 21 years of age
- 4 and older. The color designated for driver's licenses for
- 5 licensees under 21 years of age shall be at the discretion of

- 14 from buying or selling tobacco in any of its forms, to
- prohibit selling, giving or furnishing tobacco, in any of its
- 16 forms, to <u>those persons</u> minors, and providing penalties
- 17 therefor.
- 18 (720 ILCS 675/0.01) (from Ch. 23, par. 2356.9)
- 19 Sec. 0.01. Short title. This Act may be cited as the
- 20 Sale of Tobacco to <u>Underage Persons</u> Miners Act.

- Sec. 1. Except as otherwise provided in this Section, no

- 9 (3) Places where alcoholic beverages are sold and

- 31 tobacco products to persons under 19 18 years of age.

- 1 (720 ILCS 680/3) (from Ch. 23, par. 2358-23)
- 2 Sec. 3. No person shall sell any smokeless tobacco
- 3 product to any person under the age of 19 18. Any person who
- 4 violates this Section shall be guilty of a business offense
- 5 punishable by a fine of not more than \$50 for each violation.

- 7 (720 ILCS 680/4) (from Ch. 23, par. 2358-24)
- 8 Sec. 4. No person shall distribute or cause to be
- 9 distributed to any person under the age of 19 18, without

- 11 Any person who violates this Section shall be guilty of a
- 12 business offense punishable for a first offense by a fine of
- \$200, for a second offense in a 12-month period by a fine of

- 27 accessories or smoking herbs to <u>persons under 19 years of age</u>

- 30 Sec. 2. Purpose. The sale and possession of marijuana,

- 1 hashish, cocaine, opium and their derivatives, is not only
- 2 prohibited by Illinois Law, but the use of these substances
- 3 has been deemed injurious to the health of the user.
- 4 It has further been determined by the Surgeon General of
- 5 the United States that the use of tobacco is hazardous to
- 6 human health.
- 7 The ready availability of smoking herbs to <u>persons under</u>
- 8 19 years of age miners could lead to the use of tobacco and
- 9 illegal drugs.
- 10 It is in the best interests of the citizens of the State
- of Illinois to seek to prohibit the spread of illegal drugs,

- 9 delivered, or given away by use of a vending or coin-operated
- 10 machine or device. For purposes of this Section, "cigarette
- 11 paper" shall not include any paper that is incorporated into
- 12 a product to which a tax stamp must be affixed under the
- 13 Cigarette Tax Act or the Cigarette Use Tax Act.
- 14 (d) Use of identification cards. No person in the
- 15 furtherance or facilitation of obtaining smoking accessories
- 16 and smoking herbs shall display or use a false or forged
- 17 identification card or transfer, alter, or deface an
- 18 identification card.
- 19 (e) Warning to persons under 19 years of age minors.
- 20 Any person, firm, partnership, company or corporation
- 21 operating a place of business where tobacco accessories and
- 22 smoking herbs are sold or offered for sale shall post in a
- 23 conspicuous place upon the premises a sign upon which there
- 24 shall be imprinted the following statement, "SALE OF TOBACCO
- 25 ACCESSORIES AND SMOKING HERBS TO PERSONS UNDER <u>NINETEEN</u>
- 26 EIGHTEEN YEARS OF AGE OR THE MISREPRESENTATION OF AGE TO
- 27 PROCURE SUCH A SALE IS PROHIBITED BY LAW". The sign shall be
- 28 printed on a white card in red letters at least one-half inch
- 29 in height.
