- Sec. 12-4.10. Drug related child endangerment.
- 8 (a) A person commits the offense of drug related child
- 9 <u>endangerment</u> when he or she endangers the life and health of
- 10 <u>a child by knowingly exposing the child to a clandestine drug</u>
- 11 <u>laboratory environment by performing any of the following</u>
- 12 <u>acts:</u>
- 13 <u>(1) producing, manufacturing, or preparing a</u>
- 14 <u>controlled substance; or</u>
- (2) producing, manufacturing, or preparing an
- 16 <u>ingredient required to manufacture a controlled</u>
- 17 <u>substance; or</u>
- 18 (3) storing chemicals used in the controlled
- 19 <u>substance manufacturing process in a structure to which</u>
- 20 <u>the child has access; or</u>
- 21 (4) storing contaminated apparatus used in the
- 22 <u>controlled substance manufacturing process in a structure</u>
- 23 <u>to which the child has access; or</u>
- 24 (5) storing chemical waste and other by-products
- 25 <u>created during the controlled substance manufacturing</u>
