

1 AN ACT concerning higher education.

2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

4 Section 5. The University of Illinois Act is amended by
5 adding Section 25 as follows:

6 (110 ILCS 305/25 new)

7 Sec. 25. Faculty tenure; point system. The Board of
8 Trustees shall implement a point system to evaluate whether
9 or not a faculty member should receive tenure. The awarding
10 of points must be done by the head of the faculty member's
11 department. Points must be given to the faculty member based
12 on the quality of the job the faculty member has done,
13 including his or her performance in the classroom, the number
14 of publications he or she has authored, community service
15 participation, and service to the department.

16 Section 10. The Southern Illinois University Management
17 Act is amended by adding Section 15 as follows:

18 (110 ILCS 520/15 new)

19 Sec. 15. Faculty tenure; point system. The Board shall
20 implement a point system to evaluate whether or not a faculty
21 member should receive tenure. The awarding of points must be
22 done by the head of the faculty member's department. Points
23 must be given to the faculty member based on the quality of
24 the job the faculty member has done, including his or her
25 performance in the classroom, the number of publications he
26 or she has authored, community service participation, and
27 service to the department.

28 Section 15. The Chicago State University Law is amended

1 by adding Section 5-120 as follows:

2 (110 ILCS 660/5-120 new)

3 Sec. 5-120. Faculty tenure; point system. The Board shall
4 implement a point system to evaluate whether or not a faculty
5 member should receive tenure. The awarding of points must be
6 done by the head of the faculty member's department. Points
7 must be given to the faculty member based on the quality of
8 the job the faculty member has done, including his or her
9 performance in the classroom, the number of publications he
10 or she has authored, community service participation, and
11 service to the department.

12 Section 20. The Eastern Illinois University Law is
13 amended by adding Section 10-120 as follows:

14 (110 ILCS 665/10-120 new)

15 Sec. 10-120. Faculty tenure; point system. The Board
16 shall implement a point system to evaluate whether or not a
17 faculty member should receive tenure. The awarding of points
18 must be done by the head of the faculty member's department.
19 Points must be given to the faculty member based on the
20 quality of the job the faculty member has done, including his
21 or her performance in the classroom, the number of
22 publications he or she has authored, community service
23 participation, and service to the department.

24 Section 25. The Governors State University Law is amended
25 by adding Section 15-120 as follows:

26 (110 ILCS 670/15-120 new)

27 Sec. 15-120. Faculty tenure; point system. The Board
28 shall implement a point system to evaluate whether or not a
29 faculty member should receive tenure. The awarding of points

1 must be done by the head of the faculty member's department.
2 Points must be given to the faculty member based on the
3 quality of the job the faculty member has done, including his
4 or her performance in the classroom, the number of
5 publications he or she has authored, community service
6 participation, and service to the department.

7 Section 30. The Illinois State University Law is amended
8 by adding Section 20-125 as follows:

9 (110 ILCS 675/20-125 new)

10 Sec. 20-125. Faculty tenure; point system. The Board
11 shall implement a point system to evaluate whether or not a
12 faculty member should receive tenure. The awarding of points
13 must be done by the head of the faculty member's department.
14 Points must be given to the faculty member based on the
15 quality of the job the faculty member has done, including his
16 or her performance in the classroom, the number of
17 publications he or she has authored, community service
18 participation, and service to the department.

19 Section 35. The Northeastern Illinois University Law is
20 amended by adding Section 25-120 as follows:

21 (110 ILCS 680/25-120 new)

22 Sec. 25-120. Faculty tenure; point system. The Board
23 shall implement a point system to evaluate whether or not a
24 faculty member should receive tenure. The awarding of points
25 must be done by the head of the faculty member's department.
26 Points must be given to the faculty member based on the
27 quality of the job the faculty member has done, including his
28 or her performance in the classroom, the number of
29 publications he or she has authored, community service
30 participation, and service to the department.

1 Section 40. The Northern Illinois University Law is
2 amended by adding Section 30-130 as follows:

3 (110 ILCS 685/30-130 new)

4 Sec. 30-130. Faculty tenure; point system. The Board
5 shall implement a point system to evaluate whether or not a
6 faculty member should receive tenure. The awarding of points
7 must be done by the head of the faculty member's department.
8 Points must be given to the faculty member based on the
9 quality of the job the faculty member has done, including his
10 or her performance in the classroom, the number of
11 publications he or she has authored, community service
12 participation, and service to the department.

13 Section 45. The Western Illinois University Law is
14 amended by adding Section 35-125 as follows:

15 (110 ILCS 690/35-125 new)

16 Sec. 35-125. Faculty tenure; point system. The Board
17 shall implement a point system to evaluate whether or not a
18 faculty member should receive tenure. The awarding of points
19 must be done by the head of the faculty member's department.
20 Points must be given to the faculty member based on the
21 quality of the job the faculty member has done, including his
22 or her performance in the classroom, the number of
23 publications he or she has authored, community service
24 participation, and service to the department.
