- (7) Alert and abatement standards relative to water-pollution episodes or emergencies which constitute an acute danger to health or to the environment;
- (8) Requirements and procedures for the inspection of any equipment, facility, or vessel that may cause or contribute to water pollution;

- 4 (b) Notwithstanding other provisions of this Act and for purposes of implementing an NPDES program, the Board shall adopt:
 - Requirements, standards, and procedures which, (1)together with other regulations adopted pursuant to this Section 13, are necessary or appropriate to enable State of Illinois to implement and participate in the National Pollutant Discharge Elimination System (NPDES) pursuant to and under the Federal Water Pollution Control Act, as now or hereafter amended. All regulations adopted by the Board governing the NPDES program shall be consistent with the applicable provisions of such federal Act and regulations pursuant thereto, and otherwise shall be consistent with all other provisions of this Act, and shall exclude from the requirement to obtain operating permit otherwise required under this Title a facility for which an NPDES permit has been issued under Section 39(b); provided, however, that for purposes of this paragraph, a UIC permit, as required under Section 12(g) and 39(d) of this Act, is not an operating permit.
 - (2) Regulations for the exemption of any category or categories of persons or contaminant sources from the requirement to obtain any NPDES permit prescribed or from any standards or conditions governing such permit when the environment will be adequately protected without the requirement of such permit, and such exemption is either consistent with the Federal Water Pollution Control Act, as now or hereafter amended, or regulations pursuant thereto, or is necessary to avoid an arbitrary or unreasonable hardship to such category or categories of persons or sources.
