

1 AN ACT concerning boards and commissions.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 10. The Southern Illinois University Management  
5 Act is amended by changing Section 4 as follows:

6 (110 ILCS 520/4) (from Ch. 144, par. 654)

7 Sec. 4. Members of the Board shall serve without  
8 compensation but shall be entitled to reasonable amounts for  
9 expenses necessarily incurred in the performance of their  
10 duties. Such expenses incurred by any non-voting student member  
11 may, at the discretion of the Chairman of the Board, be  
12 provided for by advance payment to such member, who shall  
13 account therefor to the Board immediately after each meeting.

14 No member of the Board shall hold or be employed in or  
15 appointed to any office or place under the authority of the  
16 Board, nor shall any member of the Board be directly or  
17 indirectly interested in any contract made by the Board, nor  
18 shall he be an employee of the State ~~or Federal~~ Government.  
19 This section does not prohibit the student members of the Board  
20 from maintaining normal and official status as enrolled  
21 students or normal student employment at Southern Illinois  
22 University.

24 Section 15. The Chicago State University Law is amended by  
25 changing Section 5-20 as follows:

26 (110 ILCS 660/5-20)

27 Sec. 5-20. Reimbursement; employment limitations. Members  
28 of the Board shall serve without compensation but shall be  
29 entitled to reasonable amounts for expenses necessarily  
30 incurred in the performance of their duties. Such expenses

1 incurred by the student member may, at the discretion of the  
2 Chairman of the Board, be provided for by advance payment to  
3 the student member, who shall account therefor to the Board  
4 immediately after each meeting.

5 No member of the Board shall hold or be employed in or  
6 appointed to any office or place under the authority of the  
7 Board, nor shall any member of the Board be directly or  
8 indirectly interested in any contract made by the Board, nor  
9 shall he be an employee of the State ~~or Federal~~ Government;  
10 provided that nothing in this Section shall be deemed to  
11 prohibit the student member of the Board from maintaining  
12 normal and official status as an enrolled student or normal  
13 student employment at Chicago State University.

15 Section 20. The Eastern Illinois University Law is amended  
16 by changing Section 10-20 as follows:

18 Sec. 10-20. Reimbursement; employment limitations. Members  
19 of the Board shall serve without compensation but shall be  
20 entitled to reasonable amounts for expenses necessarily  
21 incurred in the performance of their duties. Such expenses  
22 incurred by the student member may, at the discretion of the  
23 Chairman of the Board, be provided for by advance payment to  
24 the student member, who shall account therefor to the Board  
25 immediately after each meeting.

26 No member of the Board shall hold or be employed in or  
27 appointed to any office or place under the authority of the  
28 Board, nor shall any member of the Board be directly or  
29 indirectly interested in any contract made by the Board, nor  
30 shall he be an employee of the State ~~or Federal~~ Government;  
31 provided that nothing in this Section shall be deemed to  
32 prohibit the student member of the Board from maintaining  
33 normal and official status as an enrolled student or normal  
34 student employment at Eastern Illinois University.

2 Section 25. The Governors State University Law is amended  
3 by changing Section 15-20 as follows:

4 (110 ILCS 670/15-20)

5 Sec. 15-20. Reimbursement; employment limitations. Members  
6 of the Board shall serve without compensation but shall be  
7 entitled to reasonable amounts for expenses necessarily  
8 incurred in the performance of their duties. Such expenses  
9 incurred by the student member may, at the discretion of the  
10 Chairman of the Board, be provided for by advance payment to  
11 the student member, who shall account therefor to the Board  
12 immediately after each meeting.

13 No member of the Board shall hold or be employed in or  
14 appointed to any office or place under the authority of the  
15 Board, nor shall any member of the Board be directly or  
16 indirectly interested in any contract made by the Board, nor  
17 shall he be an employee of the State ~~or Federal~~ Government;  
18 provided that nothing in this Section shall be deemed to  
19 prohibit the student member of the Board from maintaining  
20 normal and official status as an enrolled student or normal  
21 student employment at Governors State University.

24 changing Section 20-20 as follows:

26 Sec. 20-20. Reimbursement; employment limitations. Members  
27 of the Board shall serve without compensation but shall be  
28 entitled to reasonable amounts for expenses necessarily  
29 incurred in the performance of their duties. Such expenses  
30 incurred by the student member may, at the discretion of the  
31 Chairman of the Board, be provided for by advance payment to  
32 the student member, who shall account therefor to the Board

1 immediately after each meeting.

2 No member of the Board shall hold or be employed in or  
3 appointed to any office or place under the authority of the  
4 Board, nor shall any member of the Board be directly or  
5 indirectly interested in any contract made by the Board, nor  
6 shall he be an employee of the State ~~or Federal~~ Government;  
7 provided that nothing in this Section shall be deemed to

15 Sec. 25-20. Reimbursement; employment limitations. Members  
16 of the Board shall serve without compensation but shall be  
17 entitled to reasonable amounts for expenses necessarily  
18 incurred in the performance of their duties. Such expenses  
19 incurred by the student member may, at the discretion of the  
20 Chairman of the Board, be provided for by advance payment to  
21 the student member, who shall account therefor to the Board  
22 immediately after each meeting.

23 No member of the Board shall hold or be employed in or  
24 appointed to any office or place under the authority of the  
25 Board, nor shall any member of the Board be directly or  
26 indirectly interested in any contract made by the Board, nor  
27 shall he be an employee of the State ~~or Federal~~ Government;  
28 provided that nothing in this Section shall be deemed to  
29 prohibit the student member of the Board from maintaining

3 Sec. 30-20. Reimbursement; employment limitations. Members  
4 of the Board shall serve without compensation but shall be  
5 entitled to reasonable amounts for expenses necessarily  
6 incurred in the performance of their duties. Such expenses  
7 incurred by the student member may, at the discretion of the  
8 Chairman of the Board, be provided for by advance payment to  
9 the student member, who shall account therefor to the Board  
10 immediately after each meeting.

11 No member of the Board shall hold or be employed in or  
12 appointed to any office or place under the authority of the  
13 Board, nor shall any member of the Board be directly or  
14 indirectly interested in any contract made by the Board, nor  
15 shall he be an employee of the State ~~or Federal~~ Government;  
16 provided that nothing in this Section shall be deemed to  
17 prohibit the student member of the Board from maintaining

26 entitled to reasonable amounts for expenses necessarily  
27 incurred in the performance of their duties. Such expenses  
28 incurred by the student member may, at the discretion of the  
29 Chairman of the Board, be provided for by advance payment to  
30 the student member, who shall account therefor to the Board  
31 immediately after each meeting.

32 No member of the Board shall hold or be employed in or  
33 appointed to any office or place under the authority of the

1 Board, nor shall any member of the Board be directly or  
2 indirectly interested in any contract made by the Board, nor  
3 shall he be an employee of the State ~~or Federal~~ Government;  
4 provided that nothing in this Section shall be deemed to  
5 prohibit the student member of the Board from maintaining  
6 normal and official status as an enrolled student or normal  
7 student employment at Western Illinois University.
