Be it enacted by the People of the State of Illinois,represented in the General Assembly:

ARTICLE 1

5 Section 5. The following named amount, or so much 6 thereof as may be necessary, for the purpose hereinafter named, is appropriated from the General Revenue Fund to the 7 8 Board of Trustees of Eastern Illinois University to meet the ordinary and contingent expenses of the University, including 9 payment or reimbursement to the University for personal 10 services and related costs incurred during the fiscal year 11 ending June 30, 2004 and for salaries accrued but unpaid to 12 13 academic personnel for personal services rendered during the FY 2003 academic year..... \$47,609,500 14 15 Total \$47,609,500

Section 10. The sum of \$665,700, or so much thereof as 16 17 may be necessary and remains unexpended at the close of 18 business on June 30, 2003, from a reappropriation heretofore 19 made for such purpose in Article 6, Section 15 of Public Act 92-538, is reappropriated from the Capital Development Fund 20 21 Illinois University for digitalization to Eastern infrastructure for WEIU-TV. 22

23 Section 15. The sum of \$175,250, or so much thereof as 24 may be necessary and remains unexpended at the close of 25 business on June 30, 2003, from a reappropriation heretofore 26 made for such purpose in Article 6, Section 20 of Public Act 27 92-538, is reappropriated from the Capital Development Fund 28 to the Board of Trustees of Eastern Illinois University for 29 digitalization infrastructure for WEIU-TV, in addition to

amounts previously appropriated for such purpose for this fiscal year. No contract shall be entered into or obligation incurred for any expenditure from the appropriation made in this Section until after the purposes and amounts have been approved in writing by the Governor.

Section 20. The sum of \$632,900, or so much thereof б as 7 may be necessary and remains unexpended at the close of business on June 30, 2003, from a reappropriation heretofore 8 made for such purpose in Article 6, Section 30 of Public Act 9 10 92-538, is reappropriated from the Capital Development Fund to the Board of Trustees of Eastern Illinois University to 11 purchase equipment for the renovation and expansion of Booth 12 No contract shall be entered into or obligation 13 Library. 14 incurred for any expenditure from the appropriation made in 15 this Section until after the purposes and amounts have been approved in writing by the Governor. 16

17 Section 25. The sum of \$5,430,400, or so much thereof as may be necessary and remains unexpended at the close of 18 19 business on June 30, 2003, from an appropriation heretofore made for such purpose in Article 1, Section 19 of Public Act 20 21 92-717, is reappropriated from the Capital Development Fund to the Board of Trustees of Eastern Illinois University to 22 23 purchase equipment for the renovation and expansion of the 24 Fine Arts Center. No contract shall be entered into or 25 obligation incurred for any expenditure from the appropriation made in this Section until after the purpose 26 27 and amounts have been approved in writing by the Governor.

28 Section 30. The sum of \$2,000, or so much thereof as may 29 be necessary, is appropriated from the State College and 30 University Trust Fund to the Board of Trustees of Eastern 31 Illinois University for scholarship grant awards, in 1 accordance with Public Act 91-0083.

Section 99. Effective date. This Act takes effect on
July 1, 2003.
