

1 AN ACT making appropriations.

2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated for the
8 ordinary and contingent expenses of the Office of the
9 Governor:

30 Section 10. The sum of \$100,000, or so much thereof as

1 may be necessary, is appropriated from the Governor's Grant
 2 Fund to the Office of the Governor to be expended in
 3 accordance with the terms and conditions upon which such
 4 funds were received and in the exercise of the powers or
 5 performance of the duties of the Office of the Governor.

6 ARTICLE 2

7 Section 5. The following named amounts, or so much
 8 thereof as may be necessary, respectively, for the objects
 9 and purposes hereinafter named, are appropriated from the
 10 General Revenue Fund to meet the ordinary and contingent
 11 expenses of the Office of the Lieutenant Governor:

30 The amount of \$190,000, or so much thereof as may be
 31 necessary, is appropriated from the General Revenue Fund to
 32 the Office of the Lieutenant Governor for the ordinary and

1 contingent expenses of the Illinois River Coordination
2 Council.

3 Section 10. The sum of \$100,000, or so much thereof as
4 may be necessary, is appropriated from the Agricultural
5 Premium Fund to the Office of Lieutenant Governor for all
6 costs associated with the Rural Affairs Council including any
7 grants or administration expenses.

8 Section 15. The sum of \$50,000, or so much thereof as
9 may be necessary, is appropriated from the Lieutenant
10 Governor's Grant Fund to the Office of Lieutenant Governor to
11 be expended in accordance with the terms and conditions upon
12 which such funds were received and in the exercise of the
13 powers or performance of the duties of the Office of the
14 Lieutenant Governor.

15 Section 99. Effective date. This Act takes effect on
16 July 1, 2003.
