1 AMENDMENT TO HOUSE BILL 3835

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 3835, AS AMENDED,  
3 with reference to page and line numbers of Senate Amendment No.  
4 1, on page 1, line 8, after "3-806.4", by inserting "and adding  
5 Sections 3-663 and 3-664"; and

6 on page 17, below line 14, by inserting the following:

7 "(625 ILCS 5/3-663 new)

8 Sec. 3-663. Work Zone license plates.

9 (a) The Secretary, upon receipt of an application made in  
10 the form prescribed by the Secretary, may issue special  
11 registration plates designated as Work Zone license plates. The  
12 special plates issued under this Section shall be affixed only  
13 to passenger vehicles of the first division and motor vehicles  
14 of the second division registered in accordance with subsection  
15 (a) of Section 3-815 of this Code.

16 (b) The design and color of the plates is wholly within the  
17 discretion of the Secretary. The Secretary shall prescribe  
18 stickers or decals as provided under Section 3-412 of this  
19 Code.

20 (c) An applicant for the special plate shall be charged a  
21 \$40 fee for original issuance, in addition to the appropriate  
22 registration fee or the fee designated in subsection (a) of  
23 Section 3-815. Of this fee, \$25 shall be deposited into the  
24 Transportation Safety Highway Hire-back Fund and \$15 shall be

1 deposited into the Secretary of State Special License Plate  
2 Fund, to be used by the Secretary to help defray the  
3 administrative processing costs.

4 For each registration renewal period, a \$27 fee, in  
5 addition to the appropriate registration fee or the fee  
6 designated in subsection (a) of Section 3-815, shall be  
7 charged. Of this fee, \$25 shall be deposited into the  
8 Transportation Safety Highway Hire-back Fund and \$2 shall be  
9 deposited into the Secretary of State Special License Plate  
10 Fund.

11 (625 ILCS 5/3-664 new)

12 Sec. 3-664. Road Worker license plates.

13 (a) In addition to any other special license plate, the  
14 Secretary, upon receipt of all applicable fees and applications  
15 made in the form prescribed by the Secretary of State, may  
16 issue Road Worker license plates to residents of Illinois who  
17 meet eligibility requirements prescribed by the Secretary of  
18 State. The special Road Worker plate issued under this Section  
19 shall be affixed only to passenger vehicles of the first  
20 division and motor vehicles of the second division registered  
21 in accordance with Section 3-815 of this Code.

22 (b) The design, color, and format of the plates shall be  
23 wholly within the discretion of the Secretary of State. The  
24 Secretary may, in his or her discretion, allow the plates to be  
25 issued as vanity or personalized plates in accordance with  
26 Section 3-405.1 of this Code. The plates are not required to  
27 designate "Land Of Lincoln", as prescribed in subsection (b) of  
28 Section 3-412 of this Code. The Secretary shall prescribe the  
29 eligibility requirements and, in his or her discretion, shall  
30 approve and prescribe stickers or decals as provided under  
31 Section 3-412.

32 (c) An applicant shall be charged a \$40 fee for original  
33 issuance, in addition to the appropriate registration fee or

1 the fee designated in subsection (a) of Section 3-815. Of this  
2 additional fee, \$15 shall be deposited into the Secretary of  
3 State Special License Plate Fund and \$25 shall be deposited  
4 into the Transportation Safety Highway Hire-back Fund.

5 For each registration renewal period, a \$27 fee, in  
6 addition to the appropriate registration fee or the fee  
7 designated in subsection (a) of Section 3-815, shall be  
8 charged. Of this additional fee, \$2 shall be deposited into the  
9 Secretary of State Special License Plate Fund and \$25 shall be  
10 deposited into the Transportation Safety Highway Hire-back  
11 Fund."
