# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Community Services Act is amended by 5 changing Section 1 as follows:

6 (405 ILCS 30/1) (from Ch. 91 1/2, par. 901)

Sec. 1. Purpose. It is declared to be the policy and 7 intent of the Illinois General Assembly that the Department of 8 9 Services assume leadership in facilitating Human the establishment of comprehensive and coordinated arrays of 10 private and public services for persons with mental illness, 11 persons with a developmental disability, and alcohol and drug 12 dependent citizens residing in communities throughout the 13 14 state. The Department shall work in partnership with local 15 government entities, direct service providers, voluntary associations and communities to create a system that 16 is 17 sensitive to the needs of local communities and which complements existing family and other natural supports, social 18 19 institutions and programs.

20 The goals of the service system shall include but not be 21 limited to the following: to strengthen the disabled 22 individual's independence, self-esteem and ability to participate in and contribute to community life; to insure 23 continuity of care for clients; to enable disabled persons to 24 25 access needed services, commensurate with their individual 26 wishes and needs, regardless of where they reside in the state; unnecessary institutionalization 27 to prevent and the 28 dislocation of individuals from their home communities; to provide a range of services so that persons can receive these 29 30 services in settings which do not unnecessarily restrict their liberty; and to encourage clients to move among settings as 31 32 their needs change.

1 The system shall include provision of services in the areas 2 prevention, client assessment and diagnosis, case of 3 coordination, crisis and emergency care, treatment and 4 habilitation and support services, and community residential 5 alternatives to institutional settings. The General Assembly 6 recognizes that community programs are an integral part of the 7 larger service system, which includes state-operated 8 facilities for persons who cannot receive appropriate services 9 in the community.

10 Towards achievement of these ends, the Department of Human 11 Services, working in coordination with other State agencies, 12 shall assume responsibilities pursuant to this Act, which 13 includes activities in the areas of planning, quality 14 assurance, program evaluation, community education, and the 15 provision of financial and technical assistance to local 16 provider agencies.
