Amends various Acts relating to the governance of public universities in Illinois and amends the Public Community College Act. Requires public institutions of higher education to allow a currently enrolled student who is called to active military service to complete any unfinished courses at a later date at no additional charge, unless course credit has already been given. Provides that the student must be given priority over other students in reenrolling in the course or courses. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The University of Illinois Act is amended by adding Section 35 as follows:

- 3 <u>credit has already been given. The student must be given</u>
- 4 priority over other students in reenrolling in the course or
- 5 courses.
- 6 Section 50. The Public Community College Act is amended by
- 7 changing Section 3-21 and by adding Section 3-26.5 as follows:
- 8 (110 ILCS 805/3-21) (from Ch. 122, par. 103-21)
- 9 Sec. 3-21. The board of community college districts shall
- 10 have the duties enumerated in the Sections following this
- 11 <u>Section and preceding Section 3-30</u> Sections 3-22 through
- 12 $\frac{3-29\cdot 2}{}$.
- 13 Notwithstanding any provision of this Article to the
- 14 contrary, when bonds are issued by any district and the
- 15 purposes for which such bonds have been issued have been
- 16 accomplished and paid for in full and there remains funds on
- hand in such bond and interest account, the board by resolution
- 18 may transfer such excess to the fund of the district which
- 19 bears the nearest relation to the purpose for which the bonds
- from which such excess funds arose were issued.

- 24 <u>community college shall allow a currently enrolled student who</u>
- is called to active military service to complete any unfinished
- 26 <u>courses at a later date at no additional charge, unless course</u>
- 27 <u>credit has already been given. The student must be given</u>
- 28 priority over other students in reenrolling in the course or
- 29 courses.
- 30 Section 99. Effective date. This Act takes effect upon
- 31 becoming law.
