1 AN ACT in relation to criminal law.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Illinois Criminal Justice Information Act is amended by changing Section 4 as follows:

6 (20 ILCS 3930/4) (from Ch. 38, par. 210-4)

7 Sec. 4. Illinois Criminal Justice Information Authority; creation, membership, and meetings. There is created an 8 Illinois Criminal Justice Information Authority consisting of 9 21 20 members. The membership of the Authority shall consist of 10 the Illinois Attorney General, or his or her designee, the 11 Director of the Illinois Department of Corrections, 12 the Director of the Illinois Department of State Police, 13 the 14 Sheriff of Cook County, the State's Attorney of Cook County, 15 the clerk of the circuit court of Cook County, the President of the Cook County Board of Commissioners or his or her designee, 16 17 the Superintendent of the Chicago Police Department, the Director of the Office of the State's Attorneys Appellate 18 19 Prosecutor, the Executive Director of the Illinois Enforcement Training Standards Board, the State Appellate 20 21 Defender, and the following additional members, each of whom 22 shall be appointed by the Governor: a circuit court clerk, a 23 sheriff, and a State's Attorney of a county other than Cook, a chief of police, and 6 members of the general public. 24

The Governor from time to time shall designate a Chairman of the Authority from the membership. All members of the Authority appointed by the Governor shall serve at the pleasure of the Governor for a term not to exceed 4 years. The initial appointed members of the Authority shall serve from January, 1983 until the third Monday in January, 1987 or until their successors are appointed.

The Authority shall meet at least quarterly, and all
