9 WHEREAS, Larry serves as President of the University of 10 Illinois Educational Administration Alumni Association, 11 chairperson of several North Central Evaluation teams, 12 President of the Superintendent's Roundtable, and chairperson 13 of the DuPage Education Service Region Board of Control; he 14 was appointed to the State Task Force on School Finance and 15 has presented at State and national level conventions; and

16 WHEREAS, Larry Weck's dedication to improving education 17 in Illinois is a source of inspiration to the entire 18 community and State; therefore, be it
