- Any municipality making a certified report to the Secretary of State pursuant to this Section shall notify Secretary of State, in a form prescribed by the Secretary, whenever a person named in the certified report has paid the previously reported fine or penalty or whenever the municipality determines that the original report was in A certified copy of such notification shall also be given upon request and at no additional charge to the person therein. Upon receipt of the municipality's notification or presentation of a certified copy of such notification, the Secretary of State shall terminate the suspension.
- Any municipality making a certified report to the 20 2.1 Secretary of State pursuant to this Section shall also by ordinance establish procedures for persons to challenge the 22 23 accuracy of the certified report. The violation notice shall specify the time and manner in which a hearing may be had.

(3) Service of the parking, standing, or compliance violation notice by affixing the original or a facsimile of the notice to an unlawfully parked vehicle or by handing the notice to the operator of a vehicle if he or she is present and service of an automated traffic law violation notice by mail to the address of the registered owner of the cited vehicle as recorded with the Secretary of State within 30 days after the violation. A person authorized by ordinance to issue and serve parking, standing, and compliance, or automated traffic law violation notices shall certify as to the correctness of the facts entered on the violation notice by signing his or her name to the notice at the time of service or the case of a notice produced by a computerized device, by signing a single certificate to be kept by the traffic compliance administrator attesting to the correctness of all notices produced by the device while it was under his or her control. In the case of an automated traffic law violation, the ordinance shall require a signed statement by a technician employed by the municipality or county that, based on inspection of recorded images, the motor vehicle was being operated in violation Section 11-208.5. The original or a facsimile of the violation notice or, in the case of a notice produced by a computerized device, a printed record generated by the device showing the facts entered on the notice, shall be retained by the traffic compliance administrator, and shall be a record kept in the ordinary course of

business. A parking, standing, er compliance, or automated traffic law violation notice issued, signed and served in accordance with this Section, a copy of the notice, or the computer generated record shall be prima facie correct and shall be prima facie evidence of the correctness of the facts shown on the notice. The notice, copy, or computer generated record shall be admissible in any subsequent administrative or legal proceedings.

- (4) An opportunity for a hearing for the registered owner of the vehicle cited in the parking, standing, or compliance, or automated traffic law violation notice in which the owner may contest the merits of the alleged violation, and during which formal or technical rules of evidence shall not apply; provided, however, that under Section 11-1306 of this Code the lessee of a vehicle cited in the violation notice likewise shall be provided an opportunity for a hearing of the same kind afforded the registered owner. The hearings shall be recorded, and the person conducting the hearing on behalf of the traffic compliance administrator shall be empowered to administer oaths and to secure by subpoena both the attendance and testimony of witnesses and the production relevant books and papers. Persons appearing at a hearing under this Section may be represented by counsel their expense. The ordinance may also provide for internal administrative review following the decision of the hearing officer.
- (5) Service of additional notices, sent by first class United States mail, postage prepaid, to the address of the registered owner of the cited vehicle as recorded with the Secretary of State or, under Section 11-1306 of this Code, to the lessee of the cited vehicle at the last address known to the lessor of the cited vehicle at the

time of lease. The service shall be deemed complete as of the date of deposit in the United States mail. The notices shall be in the following sequence and shall include but not be limited to the information specified herein:

(i) A second notice of violation. This notice shall specify the date and location of the violation cited in the parking, standing, or compliance, or <u>automated traffic law</u> violation notice, particular regulation violated, the vehicle make and state registration number, the fine and any penalty that may be assessed for late payment when so provided by ordinance, the availability of a hearing in which the violation may be contested on its merits, and the time and manner in which the hearing may be had. The notice of violation shall also state that failure either to pay the indicated fine and any applicable penalty, or to appear at a hearing on the merits in the time and manner specified, will result in a final determination of violation liability for the cited violation in the amount of the fine or penalty indicated, and that, upon the occurrence of a final determination of liability for the failure, and the violation exhaustion of, or failure to exhaust, available administrative or judicial procedures for review, any unpaid fine or penalty will constitute a debt due and owing the municipality.

(ii) A notice of final determination of parking, standing, or compliance, or automated traffic law violation liability. This notice shall be sent following a final determination of parking, standing, or compliance, or automated traffic law violation liability and the conclusion of judicial

review procedures taken under this Section. The notice shall state that the unpaid fine or penalty is a debt due and owing the municipality. The notice shall contain warnings that failure to pay any fine or penalty due and owing the municipality within the time specified may result in the municipality's filing of a petition in the Circuit Court to have the unpaid fine or penalty rendered a judgment as provided by this Section, or may result in suspension of the person's drivers license for failure to pay fines or penalties for 10 or more parking violations under Section 6-306.5 or 5 more automated traffic law violations under Section 11-208.5.

- (6) A Notice of impending drivers suspension. This notice shall be sent to the person liable for any fine or penalty that remains due and owing 10 or more parking violations or 5 or more unpaid on automated traffic law violations. The notice shall state that failure to pay the fine or penalty owing within 45 days of the notice's date will result in the municipality notifying the Secretary of State that the person is eligible for initiation of suspension proceedings under Section 6-306.5 of this Code. The notice shall also state that the person may obtain a photostatic copy of an original ticket imposing a fine or penalty by sending a addressed, stamped envelope to the municipality self along with a request for the photostatic copy. notice of impending drivers license suspension shall be sent by first class United States mail, postage prepaid, to the address recorded with the Secretary of State.
- (7) Final determinations of violation liability. A final determination of violation liability shall occur following failure to pay the fine or penalty after a

hearing officer's determination of violation liability and the exhaustion of or failure to exhaust any administrative review procedures provided by ordinance. Where a person fails to appear at a hearing to contest the alleged violation in the time and manner specified in a prior mailed notice, the hearing officer's determination of violation liability shall become final:

(A) upon denial of a timely petition to set aside that determination, or (B) upon expiration of the period for filing the petition without a filing having been made.

- (8) A petition to set aside a determination of parking, standing, or compliance, or automated traffic law violation liability that may be filed by a person owing an unpaid fine or penalty. The petition shall be filed with and ruled upon by the traffic compliance administrator in the manner and within the time specified by ordinance. The grounds for the petition may be limited (A) the person not having been the owner or lessee of the cited vehicle on the date the violation notice was issued, (B) the person having already paid the fine or penalty for the violation in question, and (C) excusable failure to appear at or request a new date for a hearing. With regard to municipalities with a population of 1 million or more, it shall be grounds for dismissal of parking violation if the State registration number or vehicle make specified is incorrect. After the determination of parking, standing, or compliance, or automated traffic law violation liability has been set aside upon a showing of just cause, the registered owner shall be provided with a hearing on the merits for that violation.
- (9) Procedures for non-residents. Procedures by which persons who are not residents of the municipality may contest the merits of the alleged violation without

1 attending a hearing.

- (10) A schedule of civil fines for violations of vehicular standing, parking, and compliance, and automated traffic law regulations enacted by ordinance pursuant to this Section, and a schedule of penalties for late payment of the fines, provided, however, that the total amount of the fine and penalty for any one violation shall not exceed \$250.
- (11) Other provisions as are necessary and proper to carry into effect the powers granted and purposes stated in this Section.
- (c) Any municipality establishing vehicular standing, parking, and compliance, and automated traffic law regulations under this Section may also provide by ordinance for a program of vehicle immobilization for the purpose of facilitating enforcement of those regulations. The program of vehicle immobilization shall provide for immobilizing any eligible vehicle upon the public way by presence of a restraint in a manner to prevent operation of the vehicle. Any ordinance establishing a program of vehicle immobilization under this Section shall provide:
 - (1) Criteria for the designation of vehicles eligible for immobilization. A vehicle shall be eligible for immobilization when the registered owner of the vehicle has accumulated the number of unpaid final determinations of parking, standing, or compliance, or automated traffic law violation liability as determined by ordinance.
 - (2) A notice of impending vehicle immobilization and a right to a hearing to challenge the validity of the notice by disproving liability for the unpaid final determinations of parking, standing, or compliance, or automated traffic law violation liability listed on the notice.

- 1 (3) The right to a prompt hearing after a vehicle
 2 has been immobilized or subsequently towed without
 3 payment of the outstanding fines and penalties on
 4 parking, standing, or compliance, or automated traffic
 5 law violations for which final determinations have been
- issued. An order issued after the hearing is a final administrative decision within the meaning of Section
- 8 3-101 of the Code of Civil Procedure.
- 9 (4) A post immobilization and post-towing notice 10 advising the registered owner of the vehicle of the right 11 to a hearing to challenge the validity of the 12 impoundment.
- (d) Judicial review of final determinations of parking,
 standing, and compliance, and automated traffic law
 violations and final administrative decisions issued after
 hearings regarding vehicle immobilization and impoundment
 made under this Section shall be subject to the provisions of
 the Administrative Review Law.
- 19 (e) Any fine, penalty, or part of any fine or any penalty remaining unpaid after the exhaustion of, or the 20 21 failure to exhaust, administrative remedies created under 22 this Section and the conclusion of any judicial review 23 procedures shall be a debt due and owing the municipality and, as such, may be collected in accordance with applicable 24 25 law. Payment in full of any fine or penalty resulting from a 26 standing, parking, or compliance, or automated traffic law violation shall constitute a final disposition of that 27 violation. 28
- (f) After the expiration of the period within which judicial review may be sought for a final determination of parking, standing, or compliance, or automated traffic law violation, the municipality may commence a proceeding in the Circuit Court for purposes of obtaining a judgment on the final determination of violation. Nothing in this Section

1 shall prevent a municipality from consolidating multiple 2 final determinations of parking, standing, or compliance, or 3 automated traffic law violations violation against a person 4 in a proceeding. The judgment shall have the same effect and may be enforced in the same 28 29 manner as other judgments for the recovery of money.

Except as provided in paragraph 3 of this subsection (c), vehicular traffic facing a steady red arrow signal shall not enter the intersection to make the movement indicated by the arrow and, unless entering the intersection to make a movement permitted by another signal, shall stop at a clearly marked stop line, but if there is no such stop line, before entering the crosswalk on the near side of the intersection, or if there is no such crosswalk, then before entering the intersection, and shall remain standing until an indication permitting the movement indicated by such red arrow is shown.

vehicular traffic facing any steady red signal may cautiously enter the intersection to turn right, or to turn left from a one-way street into a one-way street, after stopping as required by paragraph 1 or paragraph 2 After stopping, the driver shall of this subsection. yield the right of way to any vehicle in the intersection or approaching on another roadway so closely as to constitute an immediate hazard during the time such driver is moving across or within the intersection or junction or roadways.
