4 (a) The fees for the administration and enforcement of 5 this Act, including but not limited to, original certification, renewal and restoration, shall be set by rule. 6 7 (b) Beginning July 1, 2003, all of the fees and fines collected under this Act shall be deposited into the General 8 Professions Dedicated Fund. 9

(c) Any person who delivers a check or other payment to 10 11 the Department that is returned to the Department unpaid by the financial institution upon which it is drawn shall pay to 12 the Department, in addition to the amount already owed to the 13 Department, a fine of \$50. The fines imposed by this Section 14 in addition to any other discipline provided under this 15 are 16 Act prohibiting unlicensed practice or practice on а nonrenewed license. The Department shall notify the person 17 that payment of fees and fines shall be paid to the 18 19 Department by certified check or money order within 30 calendar days of the notification. If, after the expiration 20 21 of 30 days from the date of the notification, the person has 22 failed to submit the necessary remittance, the Department 23 shall automatically terminate the license or certificate or deny the application, without hearing. If, after termination 24 25 or denial, the person seeks a license or certificate, he or she shall apply to the Department for restoration or issuance 26 of the license or certificate and pay all fees and fines due 27 to the Department. The Department may establish a fee for the 28 processing of an application for restoration of a license or 29 30 certificate all expenses of processing this to pay application. The Director may waive the fines due under this 31 32 Section in individual cases where the Director finds that the fines would be unreasonable or unnecessarily burdensome. 33

34 However, any person whose license has expired while he

1 has been engaged (1) in federal or state service active duty, or (2) in training or education under the supervision of the 2 3 United States preliminary to induction into the military 4 service, may have his license renewed, reinstated or restored 5 without paying any lapsed renewal and restoration fees, if within 2 years after termination of such service, training or 6 7 education other than by dishonorable discharge, he furnishes the Department with satisfactory proof that he has been so 8 9 engaged and that his service, training or education has been 10 so terminated.
