- 17 Section 15. The Illinois Income Tax Act is amended by
- 18 changing Sections 509 and 510 and adding Section 507Y as
- 19 follows:
- 20 (35 ILCS 5/507Y new)
- 21 <u>Sec. 507Y. The Leukemia Treatment and Education</u>
- 22 <u>checkoff. The Department shall print on its standard</u>
- 23 <u>individual income tax form a provision indicating that if the</u>
- 24 <u>taxpayer wishes to contribute to the Leukemia Treatment and</u>
- 25 Education Fund, as authorized by this amendatory Act of the
- 26 <u>93rd General Assembly</u>, he or she may do so be stating the
- 27 amount of the contribution (not less than \$1) on the return

- 1 and that the contribution will reduce the taxpayer's refund

- 21 Each form shall contain a statement that the
- 22 contributions will reduce the taxpayer's refund or increase

- 26 If, on October 1 of any year, the total contributions to
- 27 any one of the funds made under this Section do not equal
- \$100,000 or more, the explanations and spaces for designating
