- 19 Section 15. The Illinois Income Tax Act is amended by
- 20 changing Sections 509 and 510 and by adding Section 507Y as
- 21 follows:

- Sec. 507Y. The Lou Gehrig's Disease (ALS) Research Fund
- 24 <u>checkoff</u>. The <u>Department shall print on its standard</u>
- 25 <u>individual income tax form a provision indicating that if the</u>
- 26 <u>taxpayer wishes to contribute to the Lou Gehrig's Disease</u>
- 27 (ALS) Research Fund, as authorized by this amendatory Act of

- 1 the 93rd General Assembly, he or she may do so by stating the
- 2 amount of the contribution (not less than \$1) on the return
- 3 and that the contribution will reduce the taxpayer's refund
- 4 or increase the amount of payment to accompany the return.
